The limit of the Company's liability as respects the coverages below are amended to read as follows:

COVERAGE D - LIABILITY FOR DAMAGE TO AIRCRAFT THAT ARE NOT OWNED:

PROPERTY DAMAGE LIABILITY

As respects *temporary substitute aircraft* or *non-owned aircraft*:
\$5,000,000 each *occurrence*

As respects aircraft other than *temporary substitute aircraft* or *non-owned aircraft*:
\$20,000,000 each *occurrence*

(both of the above limits are part of and not in addition to the Limit of Liability set forth in Coverage B, C or G as applicable)

COVERAGE E - LIABILITY FOR DAMAGE TO AIRCRAFT HANGARS AND CONTENTS:

PROPERTY DAMAGE LIABILITY

\$5,000,000 each *occurrence*
(as part of and not in addition to the Limit of Liability set forth in Coverage A, B, C or G as applicable)

COVERAGE F - LIABILITY FOR DAMAGE TO PERSONAL EFFECTS AND CARGO:

PROPERTY DAMAGE LIABILITY

As respects *personal effects*:
\$75,000 each *crew member* or *passenger* each *occurrence*

As respects *cargo*:
\$500,000 each *occurrence*

subject to a deductible of
NIL each **occurrence**

(both of the above limits are part of and not in addition to
the Limit of Liability set forth in Coverage A, B, C or G as
applicable)

COVERAGE K - MEDICAL EXPENSES:

As respects ***scheduled aircraft, temporary substitute aircraft*** or ***non-owned aircraft***:

\$100,000 each ***crew member*** or ***passenger*** each **occurrence**

As respects the ***Named Insured's airport premises***:

\$100,000 each person

\$500,000 each **occurrence**

COVERAGE L - PHYSICAL DAMAGE TO SCHEDULED AIRCRAFT- ALL RISKS OF LOSS

The ***insured value*** of the ***scheduled aircraft*** subject to the deductibles shown in Item 4 below.

Unless otherwise agreed to by the Company, the ***insured value*** of any ***scheduled aircraft*** that has been modified or any ***newly acquired aircraft*** shall not exceed \$20,000,000.

EXTRA EXPENSE PAYMENTS (Applicable to Coverage L)

As respects expenses for a ***temporary substitute aircraft***:

\$20,000 each day

\$1,000,000 each loss

(both payable in addition to the Limit of Liability set forth in Coverage L)

As respects expenses for rental of temporary replacement component parts:

\$500,000 each loss

(payable in addition to the Limit of Liability set forth in Coverage L)

As respects expenses for trip interruption:

\$20,000 each ***crew member*** or ***passenger*** each loss

(payable in addition to the Limit of Liability set forth in Coverage L)

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
