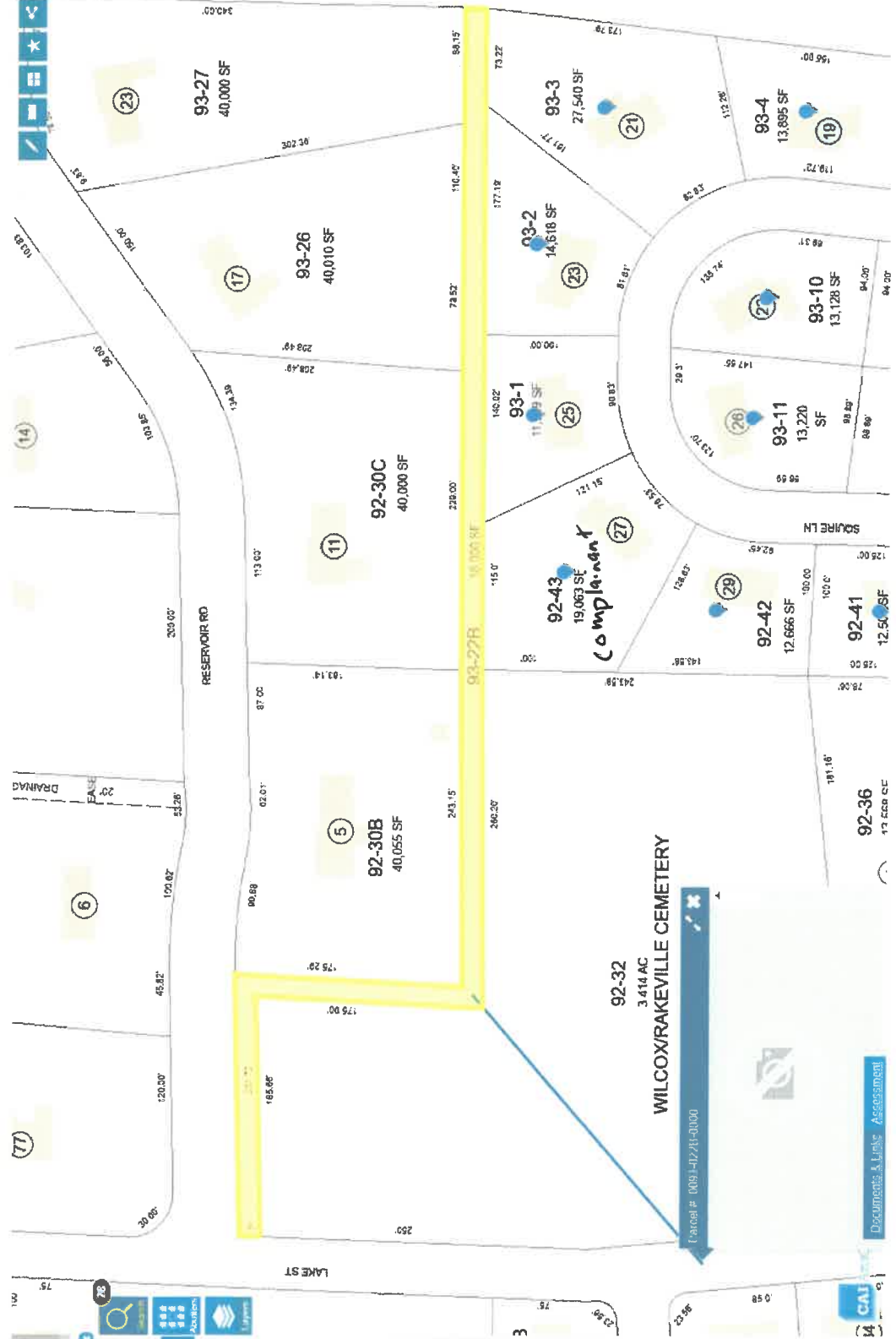

Dear Mr. and Mrs. Houde,

It has come to the attention of the board that your washing machine may not be tied into your septic system. Under Massachusetts state Title V regulations, it is **illegal** to discharge greywater into your backyard. You must notify the board of health within 60 days (no later than 1/2/24) with what actions you're taking to address this.
