Statement of Richard Haskins related to the incident on 12/10/2019 approximately 12:00 -12:30 outside the Library.

On or about 12:15-12:30 December 10th 2019 I was in the Library at the counter talking to the attendant there and heard what I thought to be students or staff outside the library shouting stop and other voices of concerns. So I hurried out from the library to where the sounds were coming from and noticed a gathering of people. I made my way to the middle of the of the crowd and saw in very close proximity to bent over wincing in pain complaining of his arm hurting and not being able to move it and was just in the motion of standing up strait from leaning over pretty much ruffled and still emotionally accelerated. I did not see any punches thrown nor did I see them locked together, what I did see was people trying to pull them apart.

I then called on the radio after I secured from out of danger, I noticed headed back towards the library along with As I was trying to get to the office Jason the Resource officer took custody of and brought him to the office, I went to retrieve to take him to the office after he gathered his belongings. So he decided to leave the library and I called out to him and several times as he was headed in the opposite direction of the office and at first I thought that he did not hear me. I then raised my voice and said and he turned to me and said, "Don't yell at me" and began to follow me towards the office. Once in the office I checked to make sure that did not sustain any injuries and that he was at a calm level before I stated to get his version of what happened.


