Hello team,

We have had a Goalview surprise today!

We apologize if this inconvenienced you and that we were unable to communicate this to you ahead of time. We did get an email from Goalview last Friday letting us know they *might* include this page in the update. We did not get a final word that it was going up and did not know what it would look like so did not feel we had enough information to share at this time.

Here is what we know:

The state assessment page was updated in Goalview. This is the <u>only</u> area of your document that has been impacted.

If you are in the middle of an IEP and have not finalized the document, you will notice that the state assessment folder turned from green to red. You will need to go into that page and make sure all the accommodations your student requires are selected.

We encourage you to NOT add any new accommodations to the IEP this year as it is new information and our students have not been trained to use these strategies. We will know more next year and will be better able to make decisions about the new accommodation and to prepare students to be successful.

If you do wish to add a new accommodation – you can do this by revising the IEP. (Remember this would be redoing the accommodations page and sending it home with a PWN.)

You do NOT need to go back and redo any IEP's you have already completed.

Kathie and the coordinators have had questions today from a few of you. Please don't hesitate to call if you have any questions.

The new information about accommodations for the SBA has recently come out from the state and continues to be revised as we speak. Last week we met with the Student Services team to review the most recent guidelines.
