Dear Neighbors,

Through a recent assessment of trees on the School District's property, it was brought to CKSD's attention that some of the recently-exposed trees north of our mutual property line may be vulnerable to prevailing winds. With your permission, the School District would like to have the trees more thoroughly evaluated by a Registered Consulting Arborist to ascertain a recommendation for keeping or removing them.

The assessment would involve the Arborist walking on your property to have a closer look at the trees. If this assessment is acceptable to you, it will take place on Wednesday,

September 13th beginning between 9-10am You do not need to be home to accompany his visit, unless you want to be in which case you are welcome to attend. He is also available to answer questions that you may have during or after his visit.
