I. Basis

1.1 Within 30 days of the filing of the Notice of Settlement of All Claims required by King County Local Rule 41(e), the parties to the action may file a Certificate of Settlement Without Dismissal with the Clerk of the Superior Court.

II. Certificate

2.1 The undersigned counsel for all parties certify that all claims have been resolved by the parties. The resolution has been reduced to writing and signed by every party. Solely for the purpose of enforcing the settlement agreement, the court is asked not to dismiss this action.

1 2.3 No further action shall be permitted except for the enforcement of the settlement agreement.
2 The parties contemplate that the final dismissal of this action will be appropriate as of June 15,
3 2023.

5 The filing of this Certificate of Settlement Without Dismissal with the clerk automatically
6 cancels any pending due dates of the Case Schedule for this action, including the scheduled trial
7 date.

9 On or after the date indicated by the parties as appropriate for final dismissal, if the
10 parties do not dismiss their case, the clerk will notify the parties that the case will be dismissed
11 by the court for want of prosecution unless within 14 days after the issuance a party makes a
12 written application to the court, showing good cause why the case should not be dismissed.
