DETECTIVE'S FIRST REPORT 21-36837-A-AR

Detective KAREN DISANO #402 Date/Time Report: 07/07/2021 1506

On 6/17/2021, Members of the SVU along with members of the CIU and Patrol Division, executed 6 court authorized search warrants simultaneously at 6 illegal massage parlors operating in the City of Cranston. The focus of the search warrants were for commerical sexual activity for a fee as well as labor and human trafficking. One of the search warrants was executed at 1340 Plainfield St, Little Genie Tanning Salon. On that date, 6/17/2021, Ann Woo was located on the property and arrested for a felony count of Pandering as well as a misdemeanor count of massage license required.

SVU Detectives were familiar with this location and Ann Woo. Woo had been identified as the owner of the property and the "mamasan" who ran the illegal massage parlor operating at that location. Woo was the target of a 2014 investigation by the Cranston Police Dept. which lead to her being arrested and charged with two counts of Licensing of Massage Therapists (23-20.8-11) and two counts of License for Massage Therapy Establishments Required (ordinance 5.25.010). This investigation occured at 1340 Plainfield St., which at the time was known as the Evergreen Day Spa and owned by Woo. Refer to Cranston Police report # 14-52653-AR. Furthermore, Woo and 1340 Plainfield St. were also the target of a 2015 investigation by the Cranston Police Dept. which lead to her being cited for municipal ordinance License for Massage Therapy Establishments Required (ordinance 5.25.010). This investigation lead to a second female at 1340 Plainfield /58), being charged with one count of Prostitution (11-34.1-2) and one count St., identifed as Ok Sun Kim of Licensing of Massage Therapists (23-20.8-11). Refer to Cranston Police report # 15-16100-AR. A standard check of Woo's national arrest record, furnished by the FBI's Interstate Identification Index (III), showed multiple arrests in multiple states involving prostitution related criminal activity, to include: Prostitution after Positive HIV Test (Ohio, 2003); Receiving Money from Earnings of Prostitution (Virginia, 2005); Keeping/Frequenting a Bawdy House (Virginia, 2005); Prostitution (Georgia, 2003); Masturbation for Hire (Georgia, 2003); Sodomy Solicitation/Solicitation Under 17 yoa (Georgia, 2003); and Giving Massages in Place Used for Lewdness, Prostitution, Assignation, or Masturbation for Hire (Georgia, 2003).

After the arrests made on 6/17/2021 at 1340 Plainfield St, SVU Detectives began to monitor the location again and learned that Ann Woo and her illegal massage parlor was back open for business . Refer to Detective Iacone's supplemental report.

On 7/7/2021, Det Iacone set up an appointment for a massage and we responded to that location. Det Iacone entered the establishment and myself, Det Fish and Det Lt Brooks monitored the situation from outside the building. Once we were given the "go" word, we proceeded inside the business where we located two females, Ann Woo and the female could produce a massage license and both were placed into custody.

I took photographs of the establishment. It should be noted that it was set up as a fully functioning massage parlor. 3 rooms were set up ready for patrons as well a a shower area and sauna room. Towels were stacked in a bin and complimentary beverages were left out for patrons.

In the kitchen area, Detectives located a ledger of patrons that had visited the establishment that day as well as a fully functioning surveillance video system that was actively monitoring the exterior of the establishment. Also in the kitchen area, Detectives located a blue "Chase" bank bag which had \$120 in cash inside, a 2019 appointment book, as well as 2 credit card receipts dated that day with the cardholder's name being card was charged, \$66.00 and his card was charged again at . At 11:28 am, 11:54 am for \$156.00 for a total of \$222.00. It should be noted that was seen exiting the business when Det Iacone was inside the establishment. was stopped in his sister's vehicle a short distance away by Det Lt Brooks. stated he was in town for his brother's funeral and was leaving to go back home to Seattle, Washington the next morning. He denied being offered or receiving any sexual services at the establishment. He alleged he received a "straight massage" from the female worker. After viewing the credit card receipts located in the business in name, and having knowledge of the fees that are charged at these locations, there is no way he paid \$222.00 for a "straight massage".

Ann Woo had 3 little dogs running around the property while we were on scene. She was allowed to call a friend identified as 'to come and take possession of the dogs. arrived shortly and was positively identified as to come and take possession of the dogs. Adams stated he would care for the dogs.

The ledger, \$120.00 cash, 2 credit card receipts, and 2019 appointment book were logged into evidence under 21-36837-A-AR.

Woo is currently out on bail from the 6/17/2021 arrest and will be violated by the AG's office.
