

## OFFICER'S FIRST REPORT 23-43775-AR Officer ALBERTO DIAZ, #524 Date/Time Report: 08/17/2023 / 1656hrs

On 08/17/2023 at approximately 1545hrs I responded to 28 Yeoman Ave for a warrant pick up. An Angelica Ferrer was currently wanted out of our department on warrant 23-219-WA.

Upon my arrival I knocked on the back door and was greeted several seconds later by Ferrer. I was able to positively identify Ferrer as I was at the residence 2 days prior for a call for service. I advised Ferrer that there was an arrest warrant for her arrest and took her into custody without incident.

Ferrer was handcuffed which were double locked and checked for for prior to placing her in the rear compartment of my patrol vehicle. She was transported to Cranston Police Headquarters where she was placed into Cell #10 awaiting arraignment.

Ferrer was charged with PROSTITUTION in violation of RIGL 11-34-1.2, OBSTRUCTING OFFICER IN EXECUTION OF DUTY in violation of RIGL 11-32-1 and FALSE REPORT OF CRIME in violation of RIGL 11-32-2.
