The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 27 day of August, 2024, at approximately 1201 a.m. <input type="checkbox"/> p.m. at 9 Royal Palm Lane, Palm Coast, Florida 32164 within Flagler County, violated the law and did then and there:					
On 8/27/2024, the St. John's County Sheriff's Office (SJSO) was alerted to a License Plate Reader (LPR) hit of a 2018 blue Ferrari bearing Florida tag CCC1 that was stolen out of Rhode Island. At approximately 1154 hours. SJSO deputies responded to the area of 100 Gateway Circle (Circle K) in Jacksonville, Florida and observed the vehicle at approximately 1157 hours. SJSO deputies advised that vehicle was observed driving extremely reckless around the 300 mile-marker. The vehicle drove on the shoulder at a high rate of speed and negotiating through traffic. The vehicle conducted multiple evasive maneuvers by taking exits and changing directions in an attempt to evade law enforcement. The vehicle ultimately entered Flagler County.					
It should be noted that Deputy Evans of SJSO responded to the Circle K at 100 Gateway Circle in Jacksonville and spoke with employees. Deputy Evans obtained still photographs of the suspect who exits the vehicle, entered the store, purchased \$20.00 worth of gas and a bottled water, pumps gas, and re-enters the vehicle as the driver and sole occupant. paid for the items with a debit card ending in 5862. In the surveillance footage, the male appears to be a skinny white male wearing a white or light-colored shirt, a necklace, and dark in color pants. The male has short, dark hair and dark facial hair on his chin.

Flagler County Sheriff's Office (FCSO) deputies were notified of a be-on-the-lookout (BOLO) for the vehicle that was stolen out of Rhode Island. The following information was obtained from the Cranston Police Department in Rhode Island:

-On 08/24/2024, the Cranston Police Department responded to an armed home invasion call for service. Through the investigation, it was discovered that the victim's were held at gunpoint by Johnathan Costa and Logan Slezak. Both Costa and Slezak had active warrants for the following charges out of Rhode Island due to the crime: breaking and entering with felony intent, using a firearm while committing a crime of violence, and conspiracy. It was known that Costa and Slezak took the 2018 blue Ferrari bearing Florida tag CCC1 during the home invasion and it was entered as stolen in NCIC.

Multiple FCSO deputies, responded to BOLO for the vehicle in Flagler County.

Deputy Barlotta and Deputy J. Dorsey, both of whom drive marked agency patrol vehicles, drove south on Old Kings Road. Deputy Dorsey observed a blue Ferrari bearing a Florida tag CCC1 at Old Kings Road and Fleetwood Drive. As the vehicle noticed Deputy Dorsey's presence, it began to accelerate, drive into oncoming traffic, and forced multiple vehicles off the road. The driver was making a clear and obvious attempt to evade deputies. Deputy Dorsey activated his lights and sirens, and a pursuit was initiated. The vehicle continued southbound at a high rate of speed while impeding the flow of traffic. Deputy Dorsey was traveling approximately 120 miles per hour (mph) and the vehicle was able to gain distance between them due to its excessive speed. The vehicle turned westbound on Palm Coast Parkway and continued with the previously mentioned driving pattern. Deputy Dorsey continued to pursue the vehicle westbound on Palm Coast Parkway. The vehicle was observed running multiple red lights and driving on the curb to avoid detainment. The vehicle entered an empty turn lane and driving through a red-light at Boulder Rock Drive and Palm Coast Parkway. The vehicle continued to flee from FCSO deputies in marked agency vehicles with their lights and sirens activated west bound on Palm Coast Parkway. The vehicle, then, turned southbound on Belle Terre Parkway from Palm Coast Parkway. Due to the high rate of speed of the suspect vehicle, visual was lost on Belle Terre Parkway. Deputies continued to BOLO for the suspect vehicle.

The suspect vehicle was observed on multiple traffic cameras and patrol dash cameras. It should be noted that the roadways were busy as it was around lunchtime in Palm Coast. In the traffic camera footage, the driver of the vehicle is wearing a white / light-colored shirt. Furthermore, in traffic camera footage and/or patrol dash camera footage the vehicle is observed driving at a high rate of speed, passing vehicles in the emergency lane, running red lights, almost causing collisions, weaving in between vehicles, and more. The vehicle was being operated in an extremely reckless manner. This footage was uploaded to evidence.com.

Through investigative means, it was discovered that Johnathan Costa is associated with Hayden Duquette-Desristofo, a resident of 9 Royal Palm Lane in Palm Coast. A be-on-the-lookout (BOLO) was conducted in the area. At 1429 hours, FCSO deputies located a blue vehicle covered by a red tarp in the yard of 9 Royal Palm Lane. The vehicle was confirmed to be the blue 2018 Ferrari 488 Spyder, bearing Florida Tag CCC1.



A perimeter was set around the residence and announcements were made. After utilizing the Crisis Negotiations Team (CNT), Johnathan Costa exited the residence and was taken into custody. While in custody, Costa was asked safety questions about any additional individuals in the residence of 9 Royal Palm Lane, to include Logan Slezak. At this time, Costa advised that Logan was in Rhode Island. Costa spontaneously uttered to Deputy Erlandson, "I came here", "I was going to return that car to his other house", "I know that doesn't matter to, it doesn't matter at all but". Due to these spontaneous statements, Deputy Erlandson read Costa his Miranda Rights. Costa invoked his Miranda Rights, and no questioning was attempted. Costa was arrested as a Fugitive of Justice for the following charges out of Rhode Island: breaking and entering with felony intent, using a firearm while committing a crime of violence, and conspiracy. It should be noted that Johnathan was wearing a white shirt and dark pants as he was taken into custody. The hair and facial hair of Costa is consistent with that of the subject in the Circle K surveillance footage obtained by SJSO.

The following interviews were conducted with witnesses:

- Master Detective Laverne conducted an interview with Jonas Gomez, who was inside of the residence of 9 Royal Palm Lane upon the arrival of law enforcement.
  - o Jonas advised that Costa disclosed to him that he had been on the run from law enforcement since he left Rhode Island.
  - o Jonas witnessed Costa park the vehicle in the backyard of 9 Royal Palm Lane, cover it, and enter the residence.
  - o Jonas adamantly denied ever being in the Ferrari or having any knowledge of its stolen status.
  - o Jonas advised that law enforcement arrived at the residence shortly after Costa's disclosure regarding the fleeing and eluding.
  - o Jonas was shown the still photographs from the surveillance footage from Circle K (100 Gateway Circle in Jacksonville, Florida). Jonas identified Costa as the male in the footage.
- Detective Costello conducted an interview with Quincy Silva, a resident of 9 Royal Palm Lane.
  - o Silva advised he received a text from Costa at 1059 hours saying, "I'll be there in a hour and 40". Quincy called Costa (401-575-7507) a minute later and told him he was at work and wouldn't be getting off until 1600 hours, but that the back door was open, and he was welcome to go to the house. A screenshot of these text message was provided to Detective Costello.
- Detective Costello, also, spoke with Alyssa DeCristoforo, resident of 9 Royal Palm Lane.
  - o Alyssa advised that after seeing the FCSO bulletin with Costa, whom she has known since he was four years old, she started making multiple calls (husband, nephew, Costa's father - nobody answered). She decided to call Costa at 1432 hours, who said he was lying on the couch. Alyssa asked him to turn himself in to the police, and he assured her he did nothing wrong.

A search warrant for the residence of 9 Royal Palm Lane in Palm Coast was obtained and signed by Honorable Judge Perkins. Upon its execution, the vehicle, a 2018 blue Ferrari bearing Florida tag CCC1, was recovered.

A hit confirmation for the stolen status of the vehicle was received by Communications Specialist #477.

The investigation revealed the following:

- Costa did operate a vehicle, having knowledge that he had been ordered to stop such vehicle by multiple duly authorized law enforcement officers, did willfully refuse or fail to stop the vehicle in compliance with such orders, did willfully flee in an attempt to elude the officers, and during the course of the fleeing or attempting to elude drove at high speed, or in any manner which demonstrated a wanton disregard for the safety of persons or property as described above, contrary to Florida Statute 316.1935(3).

- Costa did knowingly obtain or use, or endeavor to obtain or use the 2018 Blue Ferrari bearing Florida tag CCC1 of which was the property of Anthony Lombardi, or any other person not the defendant(s), with the intent to permanently or temporarily deprive Lombardi or any other person not the defendant(s) of the property or benefit therefrom or to appropriate the property to the use of Costa or to the use of any person not entitled thereto, contrary to Florida Statute 812.014(1) and (2)(c).
