On 08-27-2024 at approximately 1321 hours, I Deputy R. Towns responded to 9 Royal Palm Ln. Palm Coast, FL. in reference to security in attempt to make contact with Johnathan Costa, who was allegedly involved in a home invasion. Johnathan fled from St. John's County deputies as well as Flagler County Deputies in a stolen blue, 2-door, Ferrari bearing FL Tag # CCC1.

Through investigative techniques, it was determined that Jonathan fled to the residence of 9 Royal Palm Ln. The blue Ferrari was later located in the rear of the residence with a tarp covering it.

I considered the following factors before deploying K-9 Neo:

1. The suspect(s) had committed a home invasion with a firearm, a forcible felony in the state of Florida.
2. The suspect(s) fled and attempted to elude law enforcement in a motor vehicle.
3. The fleeing suspect(s) were unsearched and posed an immediate threat to law enforcement in their attempts to apprehend them due to concealing his location.

I then deployed K-9 Neo, a certified patrol canine, on lead in reference to security and to deter flight at the rear of the residence. K-9 Neo and I maintained our position of security until cleared by the scene commander. K-9 Neo was secured in my patrol vehicle.
