Your affiant upon oath states that he has reason to believe and does believe that grounds for issuance of an arrest warrant exists and states the following facts on which such belief is founded:							
On 8/24/24 at approximately 0320hrs, Cranston Officers were dispatched to 66 Crest Dr. for a reported armed home							
invasion. On arrival, it was learned that four residents were home at the time of the incident, two of which were minors. The							
adult victim's stated they woke up to a phone call at approximately 0309hrs. One of the victim's was held at gunpoint by two							
male suspect's, who entered through an unlocked door leading to the garage. The victim was forced to turn over car keys							
for a blue 2018 Ferrari 488 Spyder and Corvette owned by the residents. The suspects left in the Ferrari and did not get the Corvette, which was at a different location. This case was turned over to detectives for follow up. A regional BOLO was							
disseminated to all law enforcement agencies in New England. Through investigation, it was learned that the vehicle was							
subsequently located at a residence in Clinton Connecticut at 0900hrs. on 8/24/24. Later on that day, officers from that							
jurisdiction attempted to stop the vehicle, which fled the area. A follow up investigation at that residence was conducted by							
Clinton PD. This revealed the identity of the two males involved with the chase as Johnathan Costa and Logan Slezak. It							
was learned that Costa is the ex-boyfriend of the victim's daughter, and that he had been to that residence numerous times in the past. Additional video and witness testimony positively identify Costa and Slezak as the two suspects that entered 66							
Crest Dr. The Cranston Police Department is respectfully requesting an arrest warrant for Johnathan Costa for the following							
charges; (1) one count of Entering Dwelling with Felonious Intent, (1) one count of Using a Firearm when Committing a							
Crime of Violence, and (1) one count of Conspiracy.
