On 1/24/2019 while working the 0700hr to 1500hr day shift assigned to the Groton Dunstable Regional High School, I SRO. Omar A. Connor sat in on a meeting with the high school principal Mr. Woodlock and one of the freshman student's [REDACTED]. Just before [REDACTED] came down to speak with us, he had already spoken to his guidance counselor Mr. Brown and told Mr. Brown that he and his friend's hangout with a student that's been making some really bizarre and unsettling comments that were starting to bother him. Then Mr. Brown informed Mr. Woodlock and that's when Mr. Woodlock had [REDACTED] come and speak with us.

[REDACTED] told Mr. Brown, Mr. Woodlock and myself that [REDACTED] (another freshman student at GDRHS) has been making comment's that he (meaning [REDACTED]) has a machete under is bed and he can use it to be a serial killer. [REDACTED] had also said when he grow's up he wants to be a school shooter. Along with these comment's [REDACTED] said that he was going to stick his grandfather's 12 gauge in his mouth and pull the trigger. Then [REDACTED] told us that [REDACTED] has been obsessed with wanting someone to date, so [REDACTED] started to ask out some of the young ladies in the little social group they all hung out with. All the young ladies respectfully declined [REDACTED] offers and told him that they where not interested. After he kept getting rejected he then said to [REDACTED] since she said no I am going to rape her.

[REDACTED] said that [REDACTED] has been saying all the serial killer, school shooter comments for a month or 2 tops but when he started saying he was going to rape the girls that they're friends with made him tell [REDACTED] that it was not appropriate or cool at all and thought he should tell someone. [REDACTED] states that the whole group of kids he hangouts out with always tried to be a positive influence for [REDACTED] and would tell him when he would say something that was inappropriate and out of line that he should not being saying those things because he could get him in trouble. But [REDACTED] would keep going with the comment's. [REDACTED] opinion was that [REDACTED] would do this to get a reaction out of you and to shock you and really didn't believe [REDACTED] new what he was saying but still wondered if he would try to do any of it since he kept obsessing about these things.

[REDACTED] also stated that other student's in there social circle where getting tired of [REDACTED] talking about raping the girls and killing people. They asked [REDACTED] to tell [REDACTED] to stop it or to not hangout with them anymore. [REDACTED] said he would tell [REDACTED], and he would sometime's stop for a little bit and would start back up a few days or week or so later. [REDACTED] told us the names of a few other student's that heard [REDACTED] say these thing's. These student's are [REDACTED] and [REDACTED]. The other young ladies that hung out in this social circle and was mentioned by [REDACTED] are [REDACTED], [REDACTED], [REDACTED], and [REDACTED].

Mr. Woodlock then had them both come down to tell us what they new about the situation. [REDACTED] recollection of what [REDACTED] was saying was almost the same as what [REDACTED] had told us. We then asked [REDACTED] if he felt threatened by [REDACTED] and he stated that he thought [REDACTED] was just saying stuff to say it because that's what [REDACTED] does and that he also doesn't believe that [REDACTED] fully understand's most of the things he says. [REDACTED] came down after [REDACTED] left the office and told us that she new what [REDACTED] had said about her and the other girls that she hangs out with. [REDACTED] said she's heard [REDACTED] say all the same thing's that [REDACTED] and [REDACTED] did but does not think he would be capable of doing any of these things and really did not feel threatened by him. But she did feel that he was way out of line for saying that things he did about the girls, especially when they all tried to be his friend and let him hangout with them.

After the kids left Mr. Woodlocks office I left the office as well so he could call [REDACTED] down to speak with him about the accusations being made about what he's been saying. Mr. Woodlock then informed me after the meeting with [REDACTED] that [REDACTED] admitted to saying everything the kids said he did. Mr. Woodlock then called

██████████ (one of ██████████ guardians) and had him come in as soon as possible to discuss the situation. Mr. Woodlock filled me in on the meeting that he had with ██████████ and that ██████████ would not be returning to school until further notice and further ██████████.

Mr. Woodlock then called each and every parent of the student's involved with this incident and spoke with them to let them know what action has been taken and what other action will be taken. I also spoke with a few of the parents that came in and tried my best to help ease their minds on whether or not their daughter's were safe in the high school.

██████████ has been suspended until further notice from the Groton Dunstable Regional High School and this incident has been reported to the ██████████ for further investigation. The charge of (Ch.275/Sec2-Threats to commit a crime) (rape) is the charge that would be pressed against ██████████ if the Lowell Juvenile Court decides to move forward with pressing charges against him.

**Update: 2/12/2019**

DCF and a representative from the GDRSD both informed me that ██████████ will no longer be attending the GDRSD and is ██████████. DCF also informed that all the push back that the guardians had been giving the GDRSD when they tried to have ██████████ placed somewhere for an evaluation seems to have gone away and are willing to sign all the proper paperwork to let this all happen. But if they change their mind again, DCF told me they would be taking full custody of ██████████ and ██████████.

**Update: 3/12/2019**

I spoke with one of the juvenile assistant district attorneys and we discussed the most recent ██████████ incident. I asked if they would press charges on ██████████ for what he did and or said to his classmates in school. The Juvenile ADA stated that in her opinion that what ██████████ had done was not a direct threat to any one individual and most importantly their opinion is that ██████████ does not understand what he was saying. They say this due to ██████████ that his guardians withheld from the GDRSD.

**Update 5/17/2019:**

██████████ has been unenrolled from the GDRSD and ██████████ where he will continue his education and will be ██████████ he needs. He was enrolled into ██████████ after he was placed on suspension for his actions at GDRHS.
