

SUPPLEMENTAL NARRATIVE FOR PATROL PETER S BRESLIN

On December 16, 2019 Kathleen McCollumn (Middle School Principal) asked if I could attend a meeting with herself Christopher Fleming (Middle School South Assistant Principal) and the parents of two middle school students. At 0810 hours we met with and . They had some concerns about what was written in the boys bathroom. They are the parents of (7th Grade) and (5th Grade). Both students are black. They had some concerns about the safety of their children and other students of color. told us that some students think its ok to use the word nigger around their sons. No specific student was identified at that time. and spoke about an incident where rap music was being played at an afterschool basketball practice. felt uncomfortable because the word nigger was part of the lyrics and other students were singing along. One of the students singing along was identified as (8th Grade). Their son spoke up and asked that the music to be turned off. learned from another parent that had an Instagram account with racist posts about black people. also mentioned something about an AR-15 in another post. This post did not appear to be connected to the racist posts. supplied me with screen shots (See Attached) of the Instagram account. I was told that another parent notified parents of the posts and the posts were removed. and were told that if their sons experience any type of racism that they need to report it to the administration. I informed that I would speak to parents. At approximately 1300 hours I called and spoke with the mother of . She told me that she was aware of what was posted to her sons Instagram account. She was also aware of what was written in the boys bathroom at the school. The explanation that told me was that account was hacked. I told her what my concerns were and also asked if has access to firearms? She stated he does not. The only thing they have is an Airsoft gun. No one at that residence has a LTC.
