On October 15, 2021 I was working the 0700 to 1500 shift, assigned as a School Resource Officer to the Groton Dunstable Regional School District.

At 1049 hours Ann Russo (Assistant Principal) notified me of vandalism to the Middle School North upstairs 8th grade boys bathroom. I observed multiple swastika's written in pencil on the inside of the bathroom stall. I took a photo (See Image) of the vandalism and the custodian cleaned it off.

Ann Russo notified Wendy Salvatore (Principal) along with Christopher Fleming (Assistant Principal). The custodian said she checked the bathroom around 0930 hours and it was clean. Fleming said he would check the camera outside the bathroom.

At 1115 hours a teacher reported to Russo that the downstairs 8th grade boys bathroom was also vandalized. Swastika's were written on the bathroom stall. A photo (See image) was taken of the vandalism and the custodian cleaned it off. Salvatore was informed of the second incident. There is no camera in the hall outside this bathroom.

At this time it is unknown was involved and this investigation is ongoing.

On October 18, 2021 I spoke with Wendy Salvatore (Principal). She informed me that the Administration viewed the camera from Friday when the vandalism occured in the 8th grade upstairs bathroom.

I was told the custodian checks the boys bathroom Friday morning and does not see any vandalism. The Administration checks video footage from that morning. The next person who enters the bathroom after the custodian is **a set of the set of th** 

At 1000 hours Salvatore calls **we were noted** mother **we were set of**. Salvatore informs her that she needs to talk with her son about the vandalism. She stated it was ok for the Administration and the School Resource Officer talk with **we were set of** without her being present.

Salvatore, Colleen Micavich (Special Ed Team Chair MS) and I meet to discuss possible involvement. Salvatore and Micavich talk to the second second being involved with writting the swastika's.

At 1015 hours **and a set of a** 

admitted to writting two of the seven swastika's. I told him it doesnt make a difference if he wrote two or seven because what he did was wrong. He still denied writting all of them. I asked **seven** if he carved a swastika on a tree at the town field. He told me that he was not involved and that is the first time he heard about it.

Salvatore notified his mother of our findings. will face disciplinary action by the school.
