Good Afternoon Sandra.

I hope this message finds you well. I am writing to update you about the recent investigation of employee Robert Stanton. I looked into the reported issue concerning inappropriate images on the staff member's computer.

Upon conducting a thorough search and analysis, I assure you that no inappropriate images were found during the inspection of the computer in question. The investigation revealed that the root cause of the concern was attributed to a notification setting within the Chrome browser.

Specifically, the computer was experiencing spam notifications due to a setting within Chrome that the staff member inadvertently allowed. Once identified, we promptly addressed and rectified this setting to prevent further unwanted messages from appearing. In addition to fixing the issue, we took the opportunity to educate the employee on the nature of these spam notifications, explaining why they occur and how to avoid falling victim to them in the future.

Please let me know if you need any more information on this matter. Unless otherwise notified, I will mark this IT investigation of a staff member's computer and account as completed.

## Good morning -

After hearing from School Committee member Rosa - I checked my spam file for the emails you reported sending. I did find several several over the last 2 weeks. I apologize for the frustration that this has caused.

I am aware of the situation to which you refer. Obviously, it is concerning and I appreciate your diligence in ensuring that the matter does not go uninvestigated or addressed.

While the answers to your question would surely have been better in a more timely manner, I would like to answer them now:

- as to when the images were reported the staff member reported the incident as soon as it occurred. The report was made prior to any reports from students to my knowledge or that of Mr. Condon.
- The HPS IT Department immediately thoroughly searched the teacher's browser history and found no inappropriate websites visited or anything of concern on the computer. It was a thorough search to which the teacher fully cooperated.
- After speaking with your husband Mr. Condon contacted me about the situation, I agreed with your husband that out of an abundance of caution, the SRO should be notified in order to make every effort to make certain school devices were not being used for inappropriate purposes. The situation was shared with our school SRO, and the police and our IT Department communicated regarding the information. Neither feel there is any evidence that this is in any way caused by any action of the teacher.

I would agree that the parents involved should have received communication, perhaps that would have made both parents and students more confident that this was a random popup and not the result of some salacious teacher action.
