## **Dep. Grayson Supplemental**

On 05/25/22 Sgt. Bauer and I served Casey Barger with an Oder of Protection (22OP102) from Katherine Daniels in the Logan County Jail. While I was completing paperwork and going over the order of protection with him, Casey began to make statements about his charges. Casey stated that he never hit or choked Katherine. Casey stated that the only time that he choke Katherine was during sex. Casey stated that he has videos that will prove he chokes her during sex. Casey stated that Katherine asked him to choke her and that she likes when he chokes her during sex.

On 05/31/22 at 10:26 hours, I arrived to remember what all had occurred on 05/22/22 in the morning. Katherine stated that she and Casey had gotten in to a verbal argument, the verbal argument became physical and Casey choked her. Katherine stated after the physical altercation, she called her mother, Jean Ingram, and her brother Johnathan Ingram to come help her move out. I advised Katherine that Casey made a statement stating the only time he chokes her is during sexual intercourse. Katherine stated that Casey does choke her during sex, and that is the only time she was okay with him choking her. I asked Katherine when the last time Casey choked her during sexual intercourse. She stated the last time they had sexual intercourse that Casey choked her was on 05/21/22. I asked Katherine if she wanted to be choked during the physical altercation between her and Casey, she stated "no that choking was only for the bedroom". I advised Katherine I did not observe any red marks or bruising on or about her neck area when I arrived to the incident, and in the photographs taken by Sgt. Bauer there were no bruises or markings on Katherine's neck.

Katherine began to cry stating that she was having a bad day, she stated that she had a miscarriage with her baby. Katherine stated that she went to see a doctor. I advised Katherine that I was sorry for her loss, and that if she needed anything or had any questions that she could call the sheriff's office.

06/08/22 at approximately 15:30 hours, I went to to attempt to attempt to make contact with Katharine. I was not able to locate her, but did talk to Katherine's mother. Katharine's mother stated they had a doctor appointment that day at 16:30 hours. Katherine's mother stated that they would find out the cause of the miscarriage. I asked Katherine mother to have her contact me after the appointment so I could speak with her.

06/13/22 at 18:30 hours, I attempted to call Katherine, the number I had on file was disconnected. I did not have any other numbers to reach Katherine at.

06/14/22 at approximately 21:13 hours, I went to to attempt to make contact with Katherine to speak with her. The owners of the residence stated that she does not stay there anymore and she changed her phone number. They stated Katherine does not speak to them anymore. I asked them if they had heard what caused her miscarriage. They stated Katherine said something about chromosomes. I asked them if they knew where Katherine was staying at. They stated Katherine could possibly be staying at Casey's house again in I asked them if they had a working phone number for Katherine. They stated they had one, and gave me the number they had. I attempted to call the phone number, a female answered and advised she was not Katherine.

## McKenzie Supplemental

On June 1, 2022, at approximately 1936 hours Logan County Dispatch put a return phone call pending in regards to Julie Barger having additional questions on an Order of Protection (OOP) for Casey Barger. I spoke with Julie and asked if I could come to and look over the OOP her son received.

I followed up at the address and spoke Casey and Julie Barger and answered the questions they had. Casey informed me while I was there that Katherine Daniels had been messaging him stating "we can work this out." Casey also stated that he had deleted Katherine from Facebook and she has made the point to go back on his time line and "heart" past posts. He also informed me that she had been in contact with his ex-girlfriend, who he has a child with, that Katherine had called her and said that she was not going to show up to the Order of Protection hearing and that she would tell the truth about Casey not choking her to the police. I informed Casey that if he had any messages to save them and print them off for when he goes to court. Before I left the residence, Casey received a call from a doctor. The doctor informed Casey that Katherine had lost the baby.

### **DEP Grayson narrative**

On 05/22/22 at 11:46 am, Logan Dispatch received a call stating two males were actively fighting at Myself, Deputy Grayson, and Sgt. Todd Bauer were in route to I arrived on scene and observed a male standing outside by a Gray SUV with a bloody face. I asked the male, who was later identified as Johnathan Ingram, where the other male was at. Johnathan stated he was inside still fighting with his (Johnathan's) sister, Katherine Daniels.

I approached the front of the residence and could hear yelling coming from inside the house. I knocked on the front door, announced myself as "Sheriff's Office", and entered the residence. Once I entered the residence, I was met by a male that identified himself as Casey Barger. Casey appeared to have small minor injuries to his face, neck, chest and back. These injuries appeared to be scratch marks and choke marks. Casey was yelling at a female who I later identified as Katherine Daniels. I advised Casey to stop yelling and to go into the living room to speak with me so he could tell me what was going on. Sgt. Bauer went to the back room to speak with Katherine. See Sgt. Bauer's attached supplemental report.

I asked Casey what had happened. Casey stated that he woke up this morning and Katherine was mad at him and started to yell at him. Casey stated Katherine was not happy with him and would not stop yelling. Casey stated that Katherine said she was going to leave and asked her mom and brothers to come over to help her move. Casey said when Katherine's brother, Johnathan, showed up he was trying to fight, and came into the house. Casey stated that Johnathan was trying to fight in front of his asked Casey how he got all of the red markings on his face, neck, chest and back. At that time, I observed Casey to have a line of blood dripping down his face from his cheek. Casey stated when Johnathan came into the house he open-hand pushed Casey in the chest. Casey then with a closed right fist, punched Johnathan in the face. Casey stated they went to the ground that was when Johnathan wrapped his arm around Casey's neck and began to choke him. Casey stated that he began to lose air and could not breathe. Casey stated that he became light headed and thought he was going to pass out. Casey stated Johnathan let go and Casey was able to get up off the ground. Casey stated when he got up he went crazy and just began swinging both closed fist at Johnathan. Casey stated Johnathan went outside and that was when the fight stopped. Casey stated that he did not want anything more to happen due to Katherine being 12 weeks pregnant. I asked Casey if he would be willing to give a written statement. Casey agreed and provided a written statement. I attached the written statement to this report.

I went outside to speak with Johnathan to ask what had happened. Johnathan stated the following: He was at home with his mom, when his mom got a call from Katharine. Katharine stated to her mom, Jean Ingram, that Casey was putting his hands on her. Johnathan stated he went with his mom to help Katherine move her belongings. Johnathan stated that when he arrived at the residence, Casey began hitting him. Johnathan stated he put his hand on the back of Casey's head to get away. Johnathan stated that Casey began to bite him and they began to fight. Johnathan stated that he did wrap his arm around Casey's neck and began to choke him while they were fighting. Johnathan stated that he asked his mom to call the cops and then went outside to wait for us to arrive. I asked Johnathan if he would give a written statement, he stated he would and provided a written statement that I attached to this report.

I spoke with Jean Ingram (Kathrine and Johnathan's mother) and I asked Jean what had happened, she stated the following: Jean drove Johnathan and herself to pick up Katharine and her belongings. Jean stated that they arrived and they went in the house to get Katharine's belongings. Jean stated Casey began yelling and became aggressive with Johnathan. Jean grabbed her granddaughter, and put her in the vehicle. Jean stated that she stayed out of the situation because Johnathan and Casey were fighting.

Casey's mother arrived on scene and took custody of Casey's control of Casey's and Johnathan for evidence. The photos were uploaded to a CD and placed in evidence by Sgt. Bauer.

I observed the following injuries on Casey: Casey had a small cut on his right cheek with blood dripping down his face. Casey had red marks around his neck that were consistent with him being choked. Casey had a big red circle on his back right shoulder as if he had been slammed on the ground or fighting on the ground. Casey had red marks on both hands on the knuckle area as if he was punching or striking. Casey had long red marks on the front of his chest that appeared to be scratch marks.

I observed the following injuries on Johnathan: Johnathan had a bloody mouth and face with a laceration on the inside of his lower lip from being punched. Johnathan's left ear was bloody and had a cut on it where Johnathon stated Casey had bitten Johnathan's ear. Johnathan had cuts on both hands on the knuckles from punching and striking. Johnathan had multiple bite marks on him, one on the back of the neck, one on his left upper thigh and ear. Johnathan had red marks on his stomach and neck that appeared to be scratches.

I went into the residence to speak with Katherine. Sgt. Bauer was speaking with Katherine and getting a written statement from her at this time. I asked Katharine to explain what had happened she stated the following: Katharine stated she woke up that morning and Casey was upset with her about something she had done yesterday. Katharine stated that Casey was yelling at her and calling her names such as "Inbred, Illiterate fuck, stupid" and other names that were uncalled for. Katharine stated Casey wanted her to leave the house. Casey became aggressive and grabbed Katharine by the throat with both hands and squeezed, cutting off air and not

allowing her to breath. Katherine called her mom to come get her, Jean and Johnathan headed over to pick her up and get her belongings. Katherine stated that Casey threw the first punch and hit Johnathan in the face, and they continued to fight. Katharine went into the room to stay out of the fight. Katharine stated that her mom called 911. I asked Katherine if she was pregnant, she stated that she was 12 weeks pregnant. I issued the Illinois Domestic Violence Information Act Form to Katharine and explained to her how to obtain an Order of Protection. I asked Katharine if she had been given this before she stated that she had. I asked Katherine if she had any questions for me, she stated that she did not.

I went outside to speak with Johnathan. I advised Johnathan that I was arresting him for aggravated battery. I placed Johnathan in handcuffs, double locked and checked for fit. I read Johnathan his Miranda Rights and placed Johnathan in the back seat of my squad car. I went back into the residence and advised Casey that I was arresting him for Aggravated Domestic battery, and battery. I placed Casey in handcuffs, double locked and checked for fit. I read Casey his Miranda Rights, Deputy Schwerman placed Casey in the passenger seat of his squad car.

Sgt. Bauer and I transported Johnathan to Logan County Jail, Casey was released to Jail staff with no other incident. Johnathan was charged with Aggravated Battery.

Deputy Schwerman transported Casey to Logan County Jail, where he was released to Jail staff with no other incident. Casey was charged with Aggravated Domestic Battery, and Battery.

I also contacted the Department of Children of Family Services via the on-line portal and made the mandated report (reference number 14376933) due to the children being present during the altercation.

On 05/26/22 at 15:50 hours, Taylor Bartley came to the Logan County Sheriff's to show a picture of her taylor stated that when she picked her taylor Casey's mom that she noticed a red mark on the side of tace when she moved hair back from take. Taylor showed me a picture on her phone that was dated 05/23/22 at 17:49 hours (over 24 hours after the incident occurred). I observed in the photo that the red mark still looked fresh as if it just occurred. I asked Taylor if she would be willing to give a written statement, Taylor provided a statement. I attached her statement to this report. I uploaded the photo of take to a CD to place into evidence.

## Sgt. Bauer Narrative

On 5-22-2022 at approximately 11:46 am, Logan County Deputies were requested at battery report. I arrived on scene with Deputy Grayson and Deputy Schwerman a short time later.

While Deputy Grayson was speaking with Casey Barger, I spoke with Katherine Daniels, Casey's live-in girlfriend. I asked Katherine to explain what occurred. Katherine advised she and Casey have been living in the home together for a few weeks. She stated she is currently 12 weeks pregnant with Casey's child. Today, Casey and she began arguing while in her bedroom after he called her "illiterate", "inbred" and "dumb". She stated Casey then grabbed her by the throat and choked her. I asked Katherine if she lost consciousness or had trouble breathing when he did this. She stated she had trouble breathing. I asked her to explain how Casey choked her and she advised he wrapped his hands around her neck and squeezed her throat. Katherine stated he let go of her and she began packing her things. She then called her mom, Jean Ingram, and asked her to come pick her and her child up. I asked if her child was near her when the altercation took place. She stated she was holding her at the time when Casey was choking her. She advised her child was not injured or battered during the incident. I then asked where her child was at this time and asked for their name and date of birth. She advised her child's name is was uninjured and was currently outside the house with her mother.

I asked Katherine to explain what occurred once her mother arrived. She stated her mother arrived and brought her (Katherine's) brother, Johnathon Ingram, with her to help move. Katherine stated Johnathon came into the residence after she invited him inside. Casey and Johnathon began arguing about Casey choking Katherine. The argument became physical while they were arguing in the hallway. Casey punched Johnathon first and then they began hitting each other. She stated the fight continued as they entered into the living room and she didn't see anything else as she tried to stay in the bedroom and away from the fight. She stated her daughter remained with her in the bedroom until we arrived at the house. I asked Katherine if she would be willing to complete a written statement. She agreed to do so. I asked Deputy Grayson to obtain written statement forms and I obtained my camera and took photos of Katherine. I did not observe any red marks or injury around her neck area. Katherine did advise there were red marks earlier today but they had since faded. Katherine then completed her written statement.

I then took photos of the injuries Casey and Johnathon sustained during their altercation. I then assisted Dep. Grayson with the arrest

of Casey and Johnathon. Both subjects were transported to the Logan County Jail.

I uploaded all photos to the server at the Logan County Sheriff's Office. The photos were copied to CD and the CD was submitted into evidence.
