DEP Grayson Narrative

On 05/22/22 at approximately 12:28 hours, Logan Dispatch received a call from Sean Samples stating that Glenda Renee Grass (goes by Renee) had been battered by Doug Graber. I, Deputy Grayson #249, responded to [REDACTED] with Sgt. Bauer and Deputy Schwerman.

Prior to our arrival, Logan Dispatch advised that Doug had left the residence approximately 30 minutes ago. Upon arrival, I knocked on the front door and Renee answered the door. I observed Renee to have a red swollen cheek under her right eye, on her right forearm were multiple open cuts that she stated were from her dog, and one open cut on her left forearm that she stated was from Doug. On Renee's left shoulder, I observed a long scratch that had been bleeding that Renee stated was from Doug. Sgt Bauer collected photos for evidence that were copied to a CD and put in to evidence.

I asked Renee what had happened, Renee stated the following. This morning Doug wanted to use her TV for his camera's he had put up. Renee said no, then Doug tackled her to the ground in the house. Renee stated that Doug left a finger nail hole in her arm. Renee showed me her left upper shoulder that Doug made a scratch. I asked Renee if anything else had occurred during the altercation. Renee stated there was not much else to say other than, Doug came running at her and tackled her. Renee stated she flew on to the bed, and Doug finally stopped attacking her. I asked Renee if she would give a written statement. Renee completed a written statement that was attached to this report. I gave Renee an Illinois Domestic Violence Victim Information Act Form and asked her if she had any questions, Renee stated she did not.

I asked Renee where was Doug now. Renee stated that he went into the woods and was hiding. Renee stated that she could see his location on her phone through an app called find my phone that she and Doug shared. Renee showed Doug's location, SGT Bauer called Doug and asked Doug to come back to the house. Doug stated that he was on his way up to the house. SGT Bauer and I waited for approximately 30 minutes, Doug did not come back to the house. Renee stated that Doug did not move and was still in the same location. SGT Bauer, Deputy Schwerman and I walked out to Doug's last location showed and were not able to locate him. I went back to the residence to make sure Doug was not there, and advised Renee a report will be made, and that if Doug shows back up for her to call. I

Sgt. Bauer, Dep Schwerman and I cleared from the scene and patrolled the area in an attempt to locate Doug in a field or coming out of the woods. Doug was never located and we cleared from the scene with no other incident.

On 05/25/22 at 10:53 hours, Sgt. Bauer and I went to [REDACTED] in attempt to make contact with Doug after receiving a phone call from Renee. Renee stated to Sgt. Bauer that Doug was at the residence and she was no longer there. Sgt. Bauer and I knocked at the residence multiple times and no one answered. Sgt. Bauer attempted to call Doug multiple times, Doug did not answer.

On 05/26/22 at 09:55 hours, Sgt. Bauer and I arrived at [REDACTED] in attempt to make contact with Doug. I knocked on the door multiple times, no one answered. Sgt. Bauer called Doug's cell phone. Renee answered Doug's phone and stated that she was with Doug. Sgt. Bauer asked where they were at and Renee stated they were at the hotel in Atlanta IL. Renee then stated to Sgt. Bauer that Doug was not with her. Sgt. Bauer asked Renee why she had Doug's phone, Renee hung up shortly after. We attempted to make contact with Renee at the Atlanta Inn and she was not there.
