Dep. Grayson Narrative

On 06/04/22 at 08:26 hours, Logan Dispatch received a call stating a male had been hit by a car at section at large section of the section of

Lauren stated that she was traveling eastbound at 20 -25 Mph. Lauren stated that she did not see the man walking on the side of the road when she accidently hit him with her mirror. I collected Lauren's information from her while Sgt. Bauer collected pictures of Lauren's car for evidence. The photos were uploaded to a CD and placed in to evidence. I observed Lauren's passenger mirror to be broken and approximately 3-5 inch broken glass circle on the passenger side front windshield, which I believed this to be from Royle Agent's elbow.

I spoke with Royle in the ambulance who had been struck by the car. Royle stated that he was standing on the side of the road on his phone when he was hit by a car from behind. Royle stated that his back hurt and his elbow. I observed Royle's left elbow to be slightly swollen and red with approximately 1 inch cut horizontally across his elbow. Sgt. Bauer and I advised Royle that we would be in contact with him tomorrow to collect photos of his injuries. I collected Royle's information and I issued him an accident report card. I advised Royle that if he needed anything else to contact the Logan County Sheriff's Office.

At the scene of the accident, while facing eastbound, I observed the sun to be in a position that would have been in Lauren's eyes while driving. The position of the sun and Royle standing in a shaded area may have made it difficult for Lauren to see Royle. Royle stated that he was in the shaded area standing on the side of the road on his phone, facing east. Royle was wearing a green hoodie with blue jeans.
