### **Det. Park Supplemental**

On June 21, 2022 at approximately 1355 hours, I received a call from Lt. Jones with the Monticello Police Department. Lt. Jones informed me the insurance company had already paid the previous owner for the theft of the RV. He said the RV could be released to the insurance company, Grinnell Select.

At approximately 1400 hours, I spoke with Ron at Ron's Towing to inform him the RV could be released to Grinnell Select Insurance company.

### **Hopp Report**

On June 18, 2022 at approximately 0147 hours, Deputy Sean Grayson and I were patrolling in the area of the sear of the roadway, we observed a blue in color Chevrolet Trail Blazer in the driveway with the rear passenger side door open. We parked in the driveway and walked up to the vehicle to see if a potential theft or criminal damage had occurred to it. There were some items hanging out of the door.

Directly in front of the Trail Blazer, parked in the driveway, was an RV. The front of the RV was facing the front of the Trail Blazer, and they were approximately 5 feet apart. Deputy Grayson informed me he and Sgt. Todd Bauer had been on the property on May 22nd, 2022 for a Domestic Battery report, and the VIN in the windshield of the RV was covered by a piece of cardboard. I know based on prior encounters with Douglas R. Graber, who resides at that address, to have been in possession of stolen property in the past. I noticed the VIN of the RV was no longer covered.

While Deputy Grayson attempted to make contact with someone at the residence to inform them the Trail Blazer's door was open, I obtained the VIN from the dash through the windshield of the RV. There was no registration plates on the RV. The RV was white, approximately 30 feet long, and was on a Ford E-450 chassis. I was unable to check the VIN in LEADS by radio through Logan Dispatch due to poor radio service.

Deputy Grayson made contact with a Jeremy R. Eller at the front door of the residence. Jeremy stated the Trail Blazer was his but had not report to make regarding the door being open. Deputy Grayson also observed through the windows of the house what he believed to have been methamphetamine, a torch and glass pipe on the kitchen table. We asked Jeremy if Doug was home, but he said he wasn't. Deputy Grayson entered the residence only to look at the suspected methamphetamine. Deputy Grayson immediately backed out of the residence so we could contact the Logan County State's Attorney's Office about getting a warrant. We were unable to make contact with the Logan County State's Attorney's Office.

After we left the residence, I checked the VIN of the RV in LEADS via my in car computer. The return showed the RV to have been stolen. The following is the LEADS entry that was returned regarding it being stolen:



As I was informing Deputy Grayson of the RV being reported stolen, we observed an orange Mitsubishi Eclipse that I knew Doug owned. We were facing north on 1600th Avenue at the stop sign on the south side of the US Highway 136. The Eclipse had come up to the stop sign on 1600th Ave on the north side of US Highway 136 from the north. After stopping, the Eclipse continued south on 1600th Ave. Deputy Grayson turned around to follow it. I checked the registration number of the Eclipse, "The Stopping", in LEADS. The return showed the vehicle was registered to Doug and Glenda R. Grass. Doug's driver's license also showed to be revoked. Deputy Grayson said it appeared a male was driving as it passed us at the intersection of US Highway 136 and 1600th Avenue when we first observed it. I did not look into the vehicle as it passed us.

We followed the Eclipse and at approximately 0212 hours, it turned into the driveway of

, where we were

originally, and where the stolen RV was located. Deputy Grayson got out and made contact with the occupants of the Eclipse. Doug was not in the Eclipse; however, a warrant and drug arrest resulted from that contact. See Deputy Grayson's report (2022-13385) for more details.

While Deputy Grayson was with the occupants of the Eclipse, I went to the front door to make contact again. Jeremy again answered the door. Jeremy said he had been working on the RV for Doug and Glenda who had purchased it together. Jeremy said they informed him they had purchased it without a title, and Glenda said they had been working on filing paperwork with the Secretary of State to get the title. Jeremy sated he was unaware of the RV being stolen.

I asked Logan Dispatch to contact Monticello PD to inform them we located the RV, and to ask what they wanted us to do with it. Logan Dispatch advised Monticello PD asked that we tow the RV, and place a hold on the vehicle. I took photographs of the RV and its location on the property. Ron's Towing came to tow the RV. Deputy Grayson and I stayed on scene with the RV.

While we were waiting for the tow to arrive, we could see through the windows of the house Doug was moving about and turning lights on and off. We kept yelling asking Doug to come to the door but he never would. At one point we asked him to come out from the basement door that was within the house and show is hands. Doug did come out from the basement door with his hands shown and looking at us, but he just went toward the back of the house out of sight.

When tow arrived they began preparing the RV to be towed and hooking it up to the tow truck. In the process of preparing the RV to be towed, the tow operator, Matthew E. Gleason, was required to use an unlock kit to gain entry into the driver's door of the RV to release the parking brake. Matthew only opened the door, released the parking brake, and then closed the door. Nothing else was touched and no other entry was made into the RV. I also completed a tow sheet. Deputy Grayson and I followed the tow truck with the RV to their garage.

When we arrived at the Ron's Towing garage at 100 W. Kickapoo Street, I placed evidence tape on the three entry doors to the RV: The driver and passenger doors, and the RV entrance door. I photographed the RV and taped doors. At approximately 0529 hours, Ron's Towing secured the RV inside of their garage to await further instruction from Monticello PD.

When I arrived at the Logan County Safety complex for the beginning of my shift that night at approximately 1800 hours, Sgt. Todd Bauer informed me Glenda R. Grass called that day. Glenda wanted to know why the RV was towed. Sgt. Bauer informed Glenda I would contact her when I returned to work. See Sgt. Bauer's supplemental report for details.

At approximately 1945 hours, I contacted Glenda by phone. I asked Glenda to come to the Logan County Safety Complex to speak with me. She informed me she would be on her way. I asked her to bring Doug with her so I could interview him as well. Glenda said Doug was gone and she didn't know where he was.

At approximately 2050 hours, Glenda arrived at the Logan County Safety Complex Lobby and Doug was with her. Deputy Grayson and I asked Doug to speak with us first and he agreed. We escorted Doug to the Interview Room. Doug was informed how to exit the building and was informed the interview was being audio and video recorded. Doug consented to the interview being audio and video recorded. Doug initialed and signed a Statement of Miranda Rights, acknowledging and waiving his rights.

The following is a summary of the interview with Doug:

Doug said he was at home and his friend Matt Brown was there. Doug was telling Matt he wanted to find an RV to buy. Matt told Doug he knew of a cheap RV for sale. Doug and Matt went to look at the RV somewhere just east of Clinton. Doug did not know the address nor could he describe exactly what route they took. Doug described the property as having lots a weeds and a long garage. Doug said he could likely remember how to get to the property if he could actually go there.

Doug said he was happy with the RV so he agreed to purchase it for \$4000. There were two males present. Doug described the first male as being slightly taller than him (Doug said he is 5' 7" tall) and having a medium length full beard and mustache. Doug said he thought the male may have been "Mexican" and he went by the name of Bill. There was a second male Doug described to have been stocky with short hair, and a thin beard and mustache. Doug did not hear a name for the second male, but believed the residence they were at belonged to him.

Doug said he paid for the RV using \$100 and \$20 bills. He said the males he purchased the RV from said they had to be quick because DCFS was on there way to speak with them. Doug said Matt drove the RV home, and they stopped in Clinton to get gas for the RV. Doug said the only damage to the RV he was aware of was the steps to the entry door of the RV.

I asked Doug why he refused to come to the door and speak with us while we were there towing the vehicle. Doug said he was scared he was in trouble, but didn't say why he believed he may have been in trouble.

During the initial part of the interview, Doug said he had the keys to the RV in his house. Towards the end of the interview Doug said he had thrown the keys in the garbage and had since burned them in his burn barrel. Doug said the keys were likely still in the burn barrel and agreed to give them to us. I told Doug we would come to his residence later to pick up the keys. Doug was then escorted out of the building

This concludes the interview with Doug.

Next, Glenda came into the interview room. I also informed Glenda of the room being audio and video recorded and she consented. Glenda also initialed and signed a Statement of Miranda Rights, acknowledging and waiving his rights.

The following is a summary of the interview with Glenda:

Glenda said Doug and Matt were talking at Doug's house one night. She overheard Doug and Matt talking about an RV that was for sale. Doug and Matt went to look at the RV. Glenda said Doug later asked her for a ride to the bank in Atlanta so he could get money out to purchase the RV.

Then, Glenda drove Doug and Matt to the Clinton area to pick up the RV. Glenda said Matt drove the RV and Doug rode with him in the RV. The RV ran out of gas before reaching Clinton and she had to take them to a gas station in Clinton to get gas for it. Glenda had a photo of a bill of sale from the purchase of the vehicle. Glenda said her name was on the bill of sale because Doug said he might be going to prison, and wanted Glenda to be able to take care of the RV if he did. Glenda provided me the photo of the bill of sale, and a photo of the individual they purchased the RV from. According to the bill of sale, the RV was purchased on May 24th, 2022. There was no title but the bill of sale included that they still needed to provide the title. Glenda provided me the photo of the bill of sale, and a photo of the individual they purchased the RV from. Glenda had received both photos from Doug. Doug took the photos with his phone but his phone was at home during the interview so I could not get them directly from his phone.

Glenda said she became suspicious of the sale when she called both of the phone numbers the sellers gave her, and the people that answered said they did not sell her an RV.

This concludes the interview of Glenda.

On June 18, 2022 at approximately 2239 hours, Deputy Grayson and I went to Doug's house and got the keys to the RV from Doug. There were a total of 3 keys, 2 small and 1 large. I took a photograph of the keys and held them for Monticello PD.

Deputy Grayson placed all of the photos taken onto a CD and placed it into evidence. I made a second copy of the photos for the Logan County State's Attorney's Office. I also uploaded all of the photos to the photo server. I placed a copy of the audio and video recorded interviews with Doug and Glenda onto a Verbatim DVD+R and placed it into evidence, and made a second copy for the Logan County State's Attorney's Office. I scanned a copy of the tow sheet into this report.

I will be attempting to follow up with Matt Brown to get his full information and statement. I will add that information to a supplemental report when available.

**Corporal Austin Hopp** 

### Watts Supplemental

On June 18, 2022 at approximately 2:19 am I was requested to **Section 1** by Corporal Hopp. I arrived on scene at approximately 2:37 am where I met with Deputy Grayson and Corporal Hopp.

Corporal Hopp informed me to standby with an individual named Jeremy R. Eller while Corporal Hopp and Deputy Grayson continued to process the scene. While on scene, Deputy Grayson asked if I could secure the evidence collected on scene into the back of my squad car. I collected the evidence from the hood of Deputy Grayson's squad car and secured them in the trunk of my squad car. At approximately 3:02 am, Corporal Hopp advised me to transport Deputy Grayson's arrestee, Jeremy A. Maupin, to the Logan County Jail.

I arrived at the Logan County Jail at approximately 3:35 am. I completed an initial medical intake questionnaire and booking slip for Jeremy. While in the sally port of the Logan County Jail with Jeremy, I informed Jeremy I wanted to ask him two questions and would be reading his Miranda Rights. At approximately 3:40 am I read Jeremy his Miranda Rights, he acknowledged his rights and still wished to speak with me. I asked Jeremy if he had anymore illegal drugs on his person or left within the back seat of my squad car. He stated he gave all drugs and paraphernalia that was in his possession to Deputy Grayson. I asked Jeremy if there was the potential for fentanyl in the drugs that were confiscated from him. He stated he wasn't for sure but there was a possibility there could be fentanyl in the drugs. I concluded my questions for Jeremy at approximately 3:43 am and transferred custody of Jeremy to correctional staff.

While in the Logan County Jail, I served Jeremy his active Logan County Warrant on case number 2022MT76 for Failure to Appear – Driving on Revoked License at approximately 3:54 am and issued his copy to him. I left the jail and pulled around to the Logan County Safety Complex.

I retrieved the evidence from the back of my squad car, brought it into the Logan County Safety Complex, and secured it in evidence locker number #6. Once Deputy Grayson arrived at the Logan County Safety Complex, I transferred possession of the key (of evidence locker number #6) to Deputy Grayson.

### **Grayson Report**

On 06/18/22 at approximately 02:00 hours, Cpl. Hopp and I were patrolling westbound on 2575th St. I observed a blue SUV with an open door with belongings hanging out of the back passenger door at the residence of the back passenger door at the residence of the back passenger door at the residence of the back passenger door on a vehicle. While walking towards the residence, I passed by a camper/RV and observed the VIN to be uncovered. I found this odd due to the VIN being covered up by a piece of cardboard approximately two weeks prior on 05/25/22. On 05/25/22 Sgt. Bauer and I were at the same residence to do a follow up with Doug inference to a domestic battery that occurred on 05/22/22 between Doug and Glenda, case number 2022-11209. On 05/25/2022, Sgt. Bauer and I observed a piece of cardboard covering the VIN as if they were trying to conceal it. Cpl. Hopp obtained the VIN,

While approaching the front door of the residence I looked into the kitchen window and observed a white crystal substance sitting on the kitchen table in plain view. While standing at the front door, I looked through the door window and observed multiple clear plastic baggies with white crystal substance inside of them sitting on the kitchen table in plain view. The clear plastic baggies were next to a

small pile of white crystal substance on the table. From my training and experience, I believed this substance to be methamphetamine. On the Kitchen table I observed a torch commonly used to smoke methamphetamine that was approximately 6 inches away from the baggies. Next to the torch was a can of butane that was approximately 10 inches away from the small pile of white crystal substance. The only other items on the kitchen table were cigarettes and paperwork. With the combination of plastic baggies and torch and butane this raised my suspicion of the white crystal substance to be methamphetamine.

In the living room next to the kitchen, I observed a white male laying on the couch asleep. I knocked on the door and the male, who was later identified as Jeremy R. Eller, answered the door. I advised Jeremy the back passenger door to the blue SUV was open with belongings hanging out of the vehicle. I advised Jeremy I wanted to make sure no one had burglarized the vehicle. Jeremy stated the only door that should be open was the back window hatch that he left open.

I advised Jeremy that I observed what I believe to be narcotics laying on the kitchen table. Jeremy stated that he did not know what was on the kitchen table and that he does not live at the residence. Jeremy stated that he was only at the residence to work on the camper for Glenda Grass and Doug Graber. I asked Jeremy where Doug and Glenda were at, Jeremy stated they were out feeding animals. I advised Jeremy that it was 0200 hours in the morning. Jeremy stated that he did not know where they went to or when they would be home. I advised Jeremy due to the suspected narcotics being in plain view I was going to enter the residence to confirm my suspicion of narcotics. I entered the kitchen and looked at a small pile of white crystal substance and the clear baggies with white crystal substance inside of them. I asked Jeremy to come out of the residence. Cpl. Hopp attempted to make contact with the State Attorney's Office to ask about applying for a search warrant. We were not able to make contact with the States Attorney's Office. I asked Jeremy to attempt to contact Doug and Glenda to speak with them but he did not have his phone with him. I advised Jeremy that due to not being able to contact the States Attorney's Office we would be leaving the residence.

We left the property heading eastbound on 2575h St. Cpl. Hopp ran the VIN number to the white 2004 Ford RV and it came back stolen out of Monticello IL. I turned north on to 1600 Ave. I came to a stop sign at 1600 Ave and Route 136. While at the stop-sign I observed what I knew to be Doug and Glenda's orange Mitsubishi with the registration of **Monticello IL** is observed a male to be driving the vehicle. I knew the registered owner Doug Graber to have a revoked license. I also needed to speak with Doug in reference to the stolen RV that was in Doug's driveway. I turned around on US Highway 136 and got behind the vehicle. I believed to have observed an object to be thrown from the vehicle but was not able to identify it. I followed the vehicle southbound on 1600 Ave, and turned west on 2575th St. The vehicle went to the residence of **Monticello IL** Doug and Glenda's residence.

The vehicle pulled into the drive way and came to a stop. A male later identified as Justin Perez exited the driver side of the vehicle very quickly. I exited my squad car quickly and did not have my audio recorder on for the first half of the incident. Only my in car camera was recording at this time. I observed a male exit the passenger side of the vehicle. I asked Justin if he was here to speak with Doug and Glenda. Justin stated that he was. I asked Justin if he could call Doug and Glenda in attempt to get ahold of them so I could speak with them in reference to the stolen RV that was in the driveway. Justin stated that he would call them. Justin took his phone out of his pocket and began to call Doug and Glenda. I asked the male passenger what his name was, and he stated it was Jason M Ross **1**. I attempted to run Jason's information through Logan Dispatch. Logan Dispatch advised that no record came back to that name. I asked him what his name was again, he stated his name was Justin W Ross **1**. I found this odd that the male was giving me two different first names and middle initials. I attempted to run that name through Logan Dispatch, Logan Dispatch, Logan Dispatch advised there was no record on that name. I advised the male that none of those names were coming back as anyone.

I asked the male if he had a warrant. I stated to the male that he was obviously lying due to him giving me two different names. The male stated he had a warrant out of Mason City. I asked him for his real name and he stated it was Jeremy A. Maupin. I ran Jeremy's information through Logan Dispatch. Jeremy came back wanted out of Sangamon County, Mason County, and Logan County. I advised Jeremy at this time I was going to place him in handcuffs. I secured Jeremy in handcuffs, double locked and checked for fit. I asked Jeremy due to two of his warrants being for possession of methamphetamine if there was going to be any on his person or in the vehicle. Jeremey stated "I have a meth pipe in my right pants pocket". I asked Jeremy if there was going to be anything else. Jeremy stated "I have a baggie of meth under my sack". I asked Jeremy how much methamphetamine he had in the baggie. Jeremy stated that he had a couple grams. I searched Jeremy and could feel a hard ball in his pants. I was not able to shake the baggie free due to the type of underwear Jeremy was wearing. I took the left handcuff off of Jeremy to let him retrieve the baggie of methamphetamine from his crotch area. Jeremy pulled out a clear baggie with white crystal substance out of his pants. I had Jeremy place the baggie on the hood of my squad car. I secured Jeremy's left hand back in the handcuff, double locked and checked for fit. I Searched Jeremy's other pockets and located EXPUNGED inside of it. I placed Jeremy's belongings in a brown paper baggie. I secured the glass pipe, methamphetamine, and EXPUNGED in evidence baggies to be logged in to evidence. I placed Jeremy in the back seat of my squad car. I read Jeremy his Miranda Rights. Jeremy stated that he understood his rights.

I ran Justin's name through Logan Dispatch, Justin came back Clear and Valid. I asked Justin if there was going to be any other drug contraband in the vehicle. Justin stated there was not. I asked Justin for consent to search the vehicle. Justin gave consent. I searched the vehicle and did not locate any weapons or drug contraband in the vehicle. I asked Justin if he was able to get ahold of Doug or Glenda, Justin stated he was not able to. I advised Justin that he was free to leave. Justin left the property with no incident.

Dep. Watts arrived on scene. I placed Jeremy in the back seat of Dep. Watts' squad car. Dep Watts collected the evidence from my squad car and transported it back to the Logan County Sherriff's Office. Dep Watts placed the evidence in to locker #6 and secured

the locker with a padlock. Dep watts later gave me the key to locker #6. Dep. Watts transported Jeremy to the Logan County Jail. Dep. Watts completed the booking paperwork and released Jeremy to the Jail staff with no incident.

I weighed the white crystal substance in the bag before field testing it. The methamphetamine in the baggie weighed 7 grams. I field tested the white crystal substance with a Mobile Detect Kit. I used Cpl. Hopp's department issued phone to use the Mobile Detect App. The Mobile Detect App gave a PDF test result back which were attached to this report. The test result came back positive for methamphetamine. I placed the methamphetamine into evidence. I collected pictures of the methamphetamine with the positive test result and glass pipe and uploaded them to the photo server. I issued Jeremy EXPUNGED.

All photos that I took as well as the Mobile Detect test results were placed onto the same evidence CD as Cpl. Hopp's photos and placed into evidence. Cpl.
