On 06/03/22 at approximately 0142 hours, Logan Dispatch received a call stating Troy Edwards threw a beer can at the back of Rebecca Warren's head. Cpl. Hopp and I responded to [REDACTED]

I approached the house Troy was sitting on the back porch drinking a miller high life beer. I asked Troy what had happened, he stated that Rebecca was accusing him of sleeping with everyone in town. Troy stated "She thinks im fucking all the neighbors and im not" I asked Troy if anything had been physical between them. Troy stated no everything was verbal. Troy stated a beer was spilt on him and Rebecca that was all.

I walked into the residence to speak with Rebecca. Rebecca was in the living room on the phone laying on the couch. I approached Rebecca and stated I am Deputy Grayson with the Logan County Sheriff's Office. Rebecca looked at me and started to laugh. Rebecca stopped then stared at me with a blank face then asked how I got into her house. I advised her Troy let me in to speak with her. Rebecca stated she was under the influence of whine. I asked Rebecca what happened tonight. Rebecca stated she did not know what I was talking about. I asked Rebecca if Troy hit her with a beer can. Rebecca stated no one threw a beer can and stated she still didn't know what I was talking about. I advised Rebeca, Troy was going to gather his belongings and leave for the night. Rebecca stated that was fine.

I asked Troy if he had somewhere he could go for the night, he stated he wanted to go to his mother's house in Lincoln. I advises Troy do to him being under the influence of alcohol, I could take him there. Troy gathered his belongings and placed them in my squad car. I transported Troy to [REDACTED]. Troy exited my squad car and went into his mother's residence with no incident.
