Dep. Grayson narrative

On 07/03/22 at approximately 2040 hours, I was traveling west on the liberty with expired registration of 10/21. I activated my emergency lights and initiated a traffic stop. We came to a stop at
I approached the passenger side of the vehicle and asked the male driver, Malik Huges, for his license and proof of insurance. Malik asked why I stopped him, I advised him that his registration is expired by almost a year. I stated to Malik that he could get out and look if he would like. Malik exited the vehicle to look. While at the vehicle I could smell a strong odor of cannabis coming from inside the vehicle. I advised Malik to wait at his car and I would be right back. I went back to my squad car and requested another unit. Cpl. Hopp stated he was in route to my location. I ran Malik information at my squad car. Malik came back a valid driver and wanted out of Mclean County for failure to appear for driving suspended.
I approached the driver side of the vehicle and asked Malik to come back to my squad car. Malik came back to my squad car and sat in the passenger seat. I advised Malik that he had an active warrant for failure to appear for driving suspended. I advised Malik at this time he was detained until the confirmation came back on his warrant. I asked Malik how much cannabis was in the vehicle. Malik stated a legal amount. I advised Malik I was going to search his vehicle. I placed Malik in handcuffs double locked and checked for fit. I placed Malik in the back seat of my squad car. Cpl. Hopp arrived on scene shortly after.
I approached the vehicle and asked the passengers, two female and one male, to exit the vehicle. I asked the male for his name. He stated he did not have to give me his name. I advised the male due to cannabis in the vehicle that he needed to provide me his name. The male started to walk away from me and stated he was not going to give me his name. I placed the male later identified as Keean Canada in handcuffs, double locked and checked for fit. I advised Keean that he needed to sit on the front of my squad car. Keean stated he had cannabis in his left pants pocket. I located a cartridge with oil cannabis concentration. I secured the cartridge to be logged in to evidence to be destroyed. I collected pictures of the cartridge. Keean later gave me his name and date of birth and age. I had Logan Dispatch run Keean's information. Logan Dispatch advised Keean was clear of warrants with no license. Cpl. Hopp range information through Logan Dispatch. came back clear and valid. Cpl Hopp range came back clear of warrants and a valid driver.
I searched the vehicle and located a blue bag with a clear plastic baggie with cannabis inside of it. I secured the baggie to be logged into evidence to be destroyed. I collected a picture of the cannabis. I located on can of Monaco Craft Cocktail (rum cocktail) on the front passenger floor board. I asked the female passenger if she was 21. Stated was not going to say whose alcohol it was. I advised it was under feet on side of the vehicle so I will issue a citation to for it. I continued to search the vehicle and located an open container of alcohol. Monaco Craft Cocktail that was little under half full in the door cup holder of where Keean was at in the vehicle. I collected both cans and collected pictures for evidence. I properly disposed of both cans of alcohol.
Logan Dispatch advised that Mclean County stated to issue a notice to appear for Malik. I advised Malik of his notice appear date and time in Mclean county. 7-26-22 at 0900 hours. I issued Malik a citation for expired registration, citation # 228103. I issued Malik a civic citation for possession of cannabis in motor vehicle, citation #00927. I issued a citation for possession of alcohol by minor, Citation #228105. I issued Keean a citation for illegal transportation of alcohol, citation #228104. I issued Keean a civil citation for possession of cannabis in motor vehicle, citation #00928. I advised Malik he was free to leave.

I uploaded the pictures that were taken to this report and share filed a copy of the in car camera audio and video to SA Office.
