On 07/06/22 at approximately 1522 hours, Logan Dispatch received a call from Barbra Duckworth an employee at Green Prairie Animal Hospital in San Jose IL. Barbra stated they had a bad check and wanted to make a police report.

The check was dated 4-11-22 for \$85. Teresa signed the check. I advised Barbra that I would attempt to make contact with Randal and Teresa. I asked Barbra what she wanted to do with the bad check. Barbra stated she would give them a chance to pay it back if they did not then she wanted to pursue charges. I advised Barbra I would make contact with them and keep her updated.

I arrived at [REDACTED]. I made contact with Brian Huffman, Randal and Teresa's son. I asked Brian if Randal and Teresa were home. Brian stated that his father Randal passed away two days ago. I asked Brian if his mother Teresa was home. Brian stated that she was not in good mental or health condition. Brian stated that she was not far away from passing away to. I advised Brian to call the Animal Hospital and to speak with them and to let them know what was going on with his mother and father. I advised Brian to call them before Monday when I do a follow up with them.

I called the Animal Hospital to advise them of what Brian stated to me. The employees stated that they would think about what they wanted to do. They stated they would give me a call on 07/07/22 to let me what they decided to do.
