On 07/06/22 at approximately 1430 hours, Logan Dispatch received a call from Barbra Duckworth an employee at Green Prairie Animal Hospital. Barbra stated that she received a bad check from a customer and wanted to make a police report.

I arrived to 30 US Highway 136 San Jose IL. I talked with Barbra who stated that on 5-31-22 a female named Courtney Skelton (Courtney's married name is Buggs but she recently has gone back to using Skelton as her last name) came to the Animal Hospital to use their service and paid with a check. Barbra stated that Courtney had been at the Animal Hospital multiple times and had a total bill of \$325 that she owed. Barbra stated they attempted to run the check three times on 5-31-22, 06-02-22, and 06-06-22. Barbra stated that the check never went through. I asked Barbra if I could have a copy of the check, Barbra made a copy of the check for me. I asked Barbra if she would like to file charges against Courtney. Barbra stated that if Courtney could pay back what she owes then no. Barbra stated that if she does not or would not pay what she owes then Barbra wanted to file charges. I advised Barbra that I would attempt to make contact with Courtney and see if she would be willing to pay back what she owes.

Courtney wrote a check for \$239.50. I attached a copy of the check to this report. Courtney's check was from SoFI Money, check #154 account # [REDACTED] routing # [REDACTED] Courtney signed the check and put in the memo box "vet". I advised Barbra that I would make a report and send it to the States Attorney's Office after I complete a follow up with Courtney.

I went to [REDACTED] where Lincoln Police Department made contact with Courtney earlier in the day. I was unable to make contact with Courtney. I reached out to Officer Clements with Lincoln Police Department. I asked Officer Clements if he knew where Courtney would be. He stated that the aforementioned address was the last known residence she was staying. I advised Officer Clements that Courtney wrote a bad check and that I needed to get ahold of her. Officer Clements stated that he has multiple reports made with Courtney writing bad check in Lincoln. I advised Officer Clements that if any of the Lincoln Police Department Officers come in contact with Courtney, I needed to speak with her.

On 07/07/22 at approximately 1030 hours, I attempted to make contact with Courtney again at [REDACTED]. The neighbors to the south (house behind where Courtney was staying at [REDACTED]) stated that they had not seen her there since Lincoln Police Department was at the residence. The neighbors stated she took some belongings out of the residence when she left.

07/20/22 at 0800 hours, I went to the San Jose location for a follow up, I spoke with Sara at the front desk. Sara stated that Courtney had went to the location in Lincoln IL. At approximately 0900 hours, I went to Green Prairie Animal Hospital in Lincoln IL, for a follow up. I spoke with Christy L Turley, who stated that she took the check from Courtney on 05-31-22. I asked Christy if Courtney had given identification when she came in. Christy stated that Courtney had a driver license. Christy stated she wrote the driver license number on top of the check. I asked Christy if she would recognize or be able to identify Courtney. Christy stated she had known Courtney for a long time and use to teach her kids at preschool. Christy stated they use to be friends and knows her personally.
