On 07/07/22 at approximately 0939 hours, I arrived to the Logan County Court House for a report of fraud. The States Attorney's Office stated a male identified as William L Jones from Springfield IL, emailed them an insurance card. The SA Office stated that the email they received was an insurance card that appeared to be altered or fake. The insurance card that was sent has been uploaded to this report. I collected documents the SA Office provided, such as a copy of the insurance card, original citation written for no insurance, and a copy of the email address from William. The SA Office provided an active phone number for William.

I called William and was able to speak with him about the insurance card. William stated he sent the insurance card Patricia Whittaker provided him. William stated it was her car and that he was just driving Patricia to and from work. William stated he was pulled over and Patricia did not have insurance with her at the time. I advised William that he displayed false insurance to the SA Office, and needed to provide an updated or true insurance card. I advised William that if he was not able to provide valid insurance that possible charges could be pending due to him displaying false insurance. William stated that he will get ahold of Patricia and try to get updated or valid insurance.

I called the insurance company Progressive. I spoke with an operator who stated that Patricia's insurance policy was cancelled in 5-01-21. Progressive stated that Patricia does not have valid or active insurance with them anymore. William Jones was pulled over by Dep. Watts on 04/13/22 at 11:16 P.M. on St. Rt. 54 / 1500 Ave EB. In a black Nissan Altima registration # [REDACTED] William was issued a citation for no insurance, citation #228604. William was given a court date of 06/13/22 at 0900 hours.
