On 07/16/22 at approximately 0913 hours, I was traveling north on Rt. 66 approaching the stop sign at 1325th St. I observed a male wearing a white t-shirt in a blue minivan not wearing his seatbelt. I turned around, got behind the vehicle with Illinois registration of [REDACTED] activated my emergency lights, and initiated a traffic stop.

I approached the driver side of the vehicle and asked the male for his license and proof of insurance. The male, who later identified as Joey M Green, stated that he did not have his license on him, but did have valid insurance for the vehicle. I asked Joey if he does not have his license with him or if he does not have one as in it was suspended or revoked. Joey stated he was revoked. I asked Joey to come back to my squad car to run his information. I ran Joey's information and Joey came back revoked. I advised Joey that I was going to issue him a citation for driving revoked.

I issued Joey a citation #228110 for driving revoked. I handed Joey his copy and advised him that he had to appear at court on 09-12-22 at 0900 hours. I advised Joey that if he was caught driving revoked again that he would be arrested and taken to jail. The vehicle was released on scene. Due to another high priority, and needing to assist another deputy, I allowed Joey to drive his vehicle to his house. Joey was not far from his residence. I followed behind Joey and the vehicle until we arrived at his residence. I observed him exit the vehicle and walk into his residence.
