On 07/16/22 at approximately 1512 hours, I was patrolling south on Lincoln Parkway at 1400 St. I observed a motorcycle traveling at a high rate of speed. My in-car Radar was activated, I observed the motorcycle speed on my radar to be 97 in a 55 MPH zone. I pulled behind the vehicle and activated my emergency lights and sirens. I caught up to the motorcycle with registration of [REDACTED] at Lincoln Parkway and 5th St. The motorcycle was stopped at the stop light, and appeared to not have not heard or seen me. I exited my vehicle and approached the male and told him to pull over. The male pulled the motorcycle over onto 5th St.
