## **Dep. Grayson Narrative**

**On 07/17/22 at approximately 0833 hours, I was parked stationary in my vehicle and observed a vehicle turn left off of Howard St, Atlanta IL, on to Rt. 66 without signaling. I pulled behind the vehicle and ran the Illinois temporary registration number [REDACTED]. I activated my emergency lights and initiated a traffic stop. We came to stop at Rt. 66 and 2250th St, Atlanta IL.**

**I approached the driver side of the vehicle, and asked the male driver for his license and proof of insurance. The male showed me valid proof of insurance for the vehicle. The male, who later identified as Curtis Giddens, stated that he was suspended. I asked the male to come back to my squad car to run his information. I ran Curtis' information and he came back Suspended out of Louisiana, Curtis stated he has been suspended in Louisiana for a long period of time, for not paying ticket fines. I advised Curtis due to him being suspended out of Louisiana that means he does not have a valid license in the state of Illinois. I advised Curtis I was issuing a warning for the no turn signal and a citation for driving suspended. I asked Curtis if someone could come pick him up and the vehicle. Curtis stated someone was on the way.**
