## Dep. Grayson Narrative

On 07/25/22 at approximately 1341 hours, Logan Dispatch received a call from Glenda Grass, stating someone had broken into the house and stole some property. I advised Logan Dispatch I was in route to [REDACTED] I arrived on scene to speak with Glenda.

Glenda stated Doug Graber broke into the house and stole meat. Glenda stated that Doug stole the ice maker and a box of Tupperware that was worth \$1000. I asked Glenda if there was anything else stolen. Glenda stated Doug stole his monitor and Security System. Glenda stated that she owned everything Doug took. I advised Glenda that she stated to Sgt. Bauer, Dep Scherman, and I that Doug bought the security system and the meat that was in the freezer. Glenda made these statements to us on 05/22/22 reference domestic call 2022-11209.

I advised Glenda that she cannot sell Doug's belongings while he is away from the house, due to Doug being served an OOP that does not allow him to be at his house. I advised Glenda that if she sells Doug's belongings or gives them away she could possibly be charged for it. I advised Glenda that if she was caught breaking into Doug's safe and garage, she could be charged with criminal damage and theft. I advised Glenda that she needed to leave Doug's belongings alone and not to damage or sell them.

I asked Glenda how she managed to get Doug kicked out of his own house. Glenda stated she told them she only pays the bills here and the judge granted her the house on the OP. I advised Glenda I found this odd due to Doug owning the house because it was his father's house, and was passed to him in the will. I advised Glenda that she does not own the safe and does not have a right to be in the safe. I advised Glenda the safe was Doug's father and was passed to Doug. Glenda stated all she wanted from the safe was the title to the truck Doug bought for her. I advised Glenda that Doug owns the truck, but put it in her name due to her being the only one with a license.

Glenda stated that she cannot move out of Doug's because she has nowhere to go. I found this statement odd due to Glenda staying in Lincoln the last 4 days on Ottawa St. I asked Glenda where she works and she stated she does not work. I asked Glenda how she pays the bills for the house. Glenda did not answer the question. I asked Glenda where she gets the money to pay for the bills or anything else. Glenda stated that it was Doug's money but goes through her checking account. I advised Glenda that she could stop paying the bills and use that money to move somewhere else that was safer. I advised Glenda that she needed to stop texting and contacting Doug multiple times a day in attempt to get him to violate the OP. Glenda stated, she only texted and called him once today. I advised Glenda, Doug stated to Sgt. Bauer and I that she had been calling and messaging him multiple times a day.

As I was talking to Glenda, Glenda's boyfriend Sean Samples walked into the house with Glenda's stepson Christopher Crawford. Christopher was carrying bags of clothes and a makeup bag. It appeared to me as if Christopher and Sean were moving into Doug's residence. I advised Glenda if anything else came up missing, she could call the Logan County Sheriff's Office to file another police report.

On 07/26/22 at approximately 1500 hours, I made contact with Doug and spoke to him about the items that were taken from his house. I asked Doug who took the items from the house and what all was taken. Doug stated Matt W Brown went to Doug's house for him and took the ice machine and the meat out of the freezer. Doug stated there was only a couple pounds of meat left in the freezer, so he took it to have food to eat. Doug stated he got the meat from a locker in Bloomington IL, and paid for it to be processed with his LINK card. Doug stated he paid for the meat with his money. I asked Doug who owned the ice machine, he stated that Glenda and he both did. Doug stated the ice machine was bought with his money that Glenda put in her checking account. I asked Doug about other items that Glenda stated was taken, Doug advised nothing else was taken by Matt or him. I advised Doug that until the OOP was dropped that he needed to stay away from the residence and could not send anyone else there for him.
