Dep. Grayson Narrative

On 07/26/22 at approximately 0627 hours, I was patrolling west on Woodlawn Street and came to the intersection of Woodlawn Road and Heitman Dr. I observed a male in the driver's seat of a red and black truck with Illinois registration stopped in the middle of the roadway. It appeared the male was attempting to pull out on to Woodlawn Road, from Heitman Dr. The truck appeared to have broken down as the male was pulling out to Woodlawn Road. I turned my squad car around to assist the driver with getting the vehicle out of the roadway. I helped push the vehicle in to Beck's Gas Station parking lot.

I asked the male driver, who later identified as Michael Evans, for his license. Michael and the female passenger, who later identified as Amy Barger, handed me their license. I went to my squad car and ran Michael's and Amy's information. Michael came back suspended and clear of warrants. I ran Amy's information she came back suspended and clear of warrants. I looked up and Michael was walking into Beck's gas station. I asked Amy where Michael was going she stated he went to wash his hands.

I advised Amy that she is suspended and that Michael was also suspended. I advised Amy that I was going to tow the vehicle. I advised Amy I was going to issue Michael a citation for driving while suspended. I asked Amy if there was any drug contraband or weapons in the vehicle. Amy stated no that she just was arrested for Drugs and Drug paraphernalia the other day. I asked Amy what drugs she was arrested for she stated it was methamphetamine and she had a glass-smoking device that was known as a bong.

I asked Amy if she had any methamphetamine or drug paraphernalia on her or in the vehicle. Amy stated she did not and gave consent to search her purse. In Amy's purse, I located a glass pipe with white/black residue in it. I observed a small amount of white substance. From my training and experience, I knew this glass-smoking device was commonly used to smoke methamphetamine. I believed the substance in the glass pipe to be methamphetamine. I placed Amy in handcuffs, double locked and checked for fit. I read Amy her Miranda Rights. I had Amy sit at the front of the vehicle. I asked Amy where the rest of her methamphetamine was. She stated that is all the methamphetamine she had was in the glass pipe. Amy stated that she had not smoked all of it yet and there was a small amount in the glass pipe.

I advised Michael I was going to tow the vehicle and issue him a citation for driving while suspended. I requested first available tow service through Logan Dispatch. Michael stated he would prefer Ron's Towing Service to tow his vehicle. I requested Ron's Towing service through Logan Dispatch. Logan Dispatch advised that Ron's Towing service was in route to my location. I placed Amy in the back seat of my squad car.

I searched the vehicle and located in the back seat behind the passenger seat was a rubber green/blue smoking device known as a bong. Amy stated the blue/green smoking device went with the glass pipe that was in her purse. I located a pink cap to a container with white substance on it located in the back seat behind the passenger seat near the rubber smoking device. I completed searching the vehicle, and did not locate any other drug contraband. I secured the glass pipe and rubber smoking device and pink cap in the trunk of my squad car.

Ron's Towing arrived and took possession of the vehicle. I issued Michael his citation #228119 for Driving While License Suspended. I advised Michael that he had court on 09/26/22 at 0900 hours, and must appear. I advised Michael he was free to leave. I transported Amy to Logan County Jail.

Amy was released to Jail staff with no incident. Amy was arrested for possession drug paraphernalia. At the time of the arrest, I observed there to be white substance inside of the glass pipe. By the time I was able to log the evidence the white substance had absorbed into liquid in the glass pipe. I field tested the liquid substance, and it tested positive for methamphetamine.

I placed all evidence into plastic evidence bags and logged them into evidence locker #1. I uploaded my in car camera audio/video to a DVD and logged it into evidence. I cloud shared my in car Camera audio/ video to the SA Office. I uploaded Pictures of evidence and attached them to this report. I uploaded a CD with pictures of evidence and logged it into evidence.
