Dep. Grayson Narrative

On 07/30/22 at approximately 1107 hours, I was patrolling south on Rt. 66, Dep Schwerman was patrolling north on Lincoln Parkway just north of 1800 St. I observed an orange Mitsubishi with Illinois registration traveling 65 MPH in a 55 MPH. I activated my emergency lights and initiated a traffic stop. We came to stop at N Lincoln Parkway / 1800 St, Lincoln.

I approached the passenger side of the car and asked the male driver, later identified as Justin Perez, for his license and proof of insurance. Justin handed me his license and an expired insurance card. I advised Justin his insurance card was expired and he needed to provide valid insurance. Justin stated that he would call Glenda Grass and get insurance for the vehicle. I asked the male and female passenger for their licenses, they provided them to me. The male identified as Nathan Ware, and the female identified as Cathy Beck. I took their licenses with me to my squad car and ran their information.

Justin came back clear and valid, Nathan came back valid and clear, and Cathy came back suspended and clear. Dep. Schwerman ran his K9 around the vehicle as I was filling out written waring for Justin. Dep. Schwerman advised his K9 did not alert on the vehicle. Justin gave consent to search the vehicle to Dep Schwerman. Dep. Schwerman did not locate any weapons or drug contraband in the vehicle. I finished my written warning and asked Justin if he had that insurance for me. Justin stated that he was still working on it.

I asked Cathy, who at this time was hugging her purse, if she had any drug contraband inside of her purse. Cathy stated that she had cannabis, and that was it. I asked her to show me the cannabis. Cathy pulled out a plastic baggie with cannabis inside of it. I advised Cathy I was going to search her purse for other drug contraband. In her purse, I located a black pouch that had a glass pipe in it with white and black residue. Cathy later stated that she uses it to smoke crack out of it and that she uses crack. In the same pouch Cathy had baking soda and copper. Cathy stated that she uses the baking soda to cut her crack with and uses it to make the crack hard so she could smoke it out of the pipe. I asked what the copper was used for she stated she uses it as a filter in her pipe. I observed there to be substance packed in the pipe. I collected the pipe for evidence and secured it in my car. Cathy also had a plastic container with white residue in the black pouch. I later field tested the tube and pipe, both were positive for crack.

Justin was able to provide valid insurance. Justin was issued a written warning for speed. Cathy was issued a civil citation for possession of cannabis in motor vehicle. I advised Justin that he was free to leave. I advised Cathy that a report would be made for the possession of drug paraphernalia and referred to the Logan County State's Attorney's Office.
