## **Dep Grayson Narrative**

On 07/30/22 at approximately 1227 hours, Logan Dispatch received a call from Glenda Grass stating Doug Graber violated his Order of Protection 22-OP-140. I have prior knowledge of the order of protection and I know Doug can't be within 500 feet of the residence as well as Glenda Grass. I advised Logan Dispatch that I was en route to the residence of Doug and Glenda's residence. Deputy Schwerman stated he was also en route to the residence. While we were en route, Logan Dispatch advised Glenda stated Doug left 5 minutes prior in a small maroon Chevrolet truck. I advised Dep. Schwerman I would head to Atlanta knowing Doug has went to Armington or Atlanta when he had left his house on previous encounters. Dep. Schwerman advised he would head towards Armington.

I called Doug's phone number we had on file for him. Doug answered and stated he was at the Shell Gas station, 102 Empire St in Atlanta, IL. I advised Doug to stay at that location so I could speak with him. I arrived at the gas station and observed Doug sitting in the passenger seat of a dark gray Ford F150 with Illinois registration of I found this odd due to Glenda stating Doug was in a small maroon Chevrolet truck. I advised Logan Dispatch and Dep. Schwerman I had located Doug and would be making contact with him. Doug was in the Dairy Queen drive through with a male, later identified as William Feezor. There was no way for them to pull out of the drive through. I parked my squad car and waited for them to exit the drive through. Dep. Schwerman arrived at my location, and shortly after William and Doug pulled out of the drive through. The two proceeded to pull up to my squad car.

I asked Doug to get into the passenger seat of my squad car so I could speak with him. Doug provided a statement in my squad car that was on Audio and Video recording. I later advised Doug that everything was being audio and video recorded in my squad car. I asked Doug where he was coming from, which he stated Armington. I asked Doug if he made any stops along the way to Atlanta. Doug admitted he and William drove past Glenda's house, located at **State Provided**, but did not stop or get out to go up to the house. I asked Doug if he had any contact with Glenda today. Doug stated he did not talk to her. I advised Doug to sit in my squad car while I spoke with William.

I went to the passenger side of William's truck and asked him where they were coming from. William advised they had left his house in Armington to come to Atlanta to get food. I asked William if they had stopped anywhere along the way to Atlanta. William stated while driving down 2575th Street, Glenda was waving at him to come to the house, William pulled into the residence to speak with her. William stated he did not know Doug had an order of protection against him for the property or Glenda. I asked William if Doug mentioned the OOP to him. William stated all Doug said was that he could not be at the house as William was pulling onto the property. I asked William what happened after that. William stated Glenda came up to the driver's side of the truck and started to talk to Doug and him. William stated shortly after, Doug got out of the truck and went up to the shed and walked into the shed with Glenda. William stated that Doug and Glenda began to argue about something. Doug then walked back to the truck and got inside. William stated Glenda then brought a soda out to Doug at which time they proceeded to leave. I asked William if he would provide a written statement, he stated that he would. As I went to get a written statement form, William stated "hey I need to tell you something but I don't want to be involved". I asked William what he needed to tell me. William stated "while Glenda was at my window, she stated she had a meth lab out at the house". William stated that he told her he does not mess with that and stated that was why he left shortly after. William then provided a written statement.

I went back to my squad car to speak with Doug. I advised William had a different story and I told Doug what William stated. Doug advised he was at the house and went to the shed because he saw someone broke into it and it was open. Doug stated he was upset because he did not want people stealing his property while he was not there. I advised Doug that Sgt. Bauer and I told him he could not be at the property and could not have contact with Glenda until the OOP was terminated. I stated to Doug I told him multiple times he would be arrested if he violated the OOP. Doug stated that Glenda waved them up to the house and was talking to him and did not have a problem with him being there. I advised Doug that as soon as they left Glenda called Logan Dispatch and reported that he violated his OOP.

I advised Doug that Glenda stated to William that there was a methamphetamine lab at the house. Doug stated he did not hear that. Doug stated with both Sean Samples and Jeremy Eller staying at his house together, they could and possibly were cooking methamphetamine in the basement. Doug stated Sean and Jeremy were both known for cooking before. I asked Doug if he would give consent to search his house. Doug stated he would give written consent. Doug completed and provided written consent later at the Logan County Jail. I advised Doug that he was under arrest for violating his OOP. Doug was arrested at 1347 hours, I placed Doug in Handcuffs, double locked and checked for fit. I allowed Doug to smoke a cigarette and to hand William his property before we left. I transported Doug to Logan County Jail. Doug was released to Jail staff with no incident. Doug was arrested for Violation of Order of Protection.

I called Dep. Schwerman and advised him Doug had provided written consent to search his residence. Dep. Schwerman was en route back to **search** to speak with Glenda and get a written statement about the Oder of Protection violation. I asked Dep. Schwerman to ask for written consent to search the residence when he was done with the written statement. I arrived at the address listed above shortly after. I approached the residence and observed Glenda completing the written consent form. Glenda handed Dep. Schwerman the consent form and stated we could search anywhere we wanted. I asked Glenda about the rumor of a meth lab at the residence, she stated she had heard there was possibly a meth lab in the basement or out in the shed but did not know for sure. I asked Glenda where Jeremy Eller was at, and she stated he was still in the basement. I advised Glenda that Jeremy had a warrant. I knew Jeremy to have a warrant due to running his information prior to my arrival.

Dep. Schwerman and I walked into the residence and went downstairs to the basement. The basement was dark and I did not locate a light switch. I had my Taser un-holstered at this time. I announced "Sheriff's Office", I advised Jeremy to make himself known and to come out with his hands up. I advised Jeremy to not jump out or attempt to run. Dep. Schwerman and I cleared the basement and located Jeremy hiding behind a table and chair behind the stairs. I advised Jeremy to come out from behind the chair and table. Jeremy did not move, I advised Jeremy I could see him and was looking at him, and that he needed to come out. Jeremy stood up from behind the chair and table. Jeremy was in black underwear and a black shirt. I advised Jeremy to keep his hands were I could see them as he came out, due to multiple knives that were on the table and floor next to the chair. Dep. Schwerman arrested Jeremy at approximately 1610 hours. Jeremy was secured in handcuffs, double locked and checked for fit. We transported Jeremy out to my squad car and placed him in the back seat of my squad car. I had Logan Dispatch confirm Jeremy's warrant out of Mclean County IL. Logan Dispatch confirmed Jeremy's warrant for contempt of court.

I requested Dep. Maslanka to our location to assist. I asked Jeremy about the rumors of the meth lab at the residence Jeremy began to speak but was told to hold on so he could be read his Miranda Rights. Dep. Schwerman read Jeremy his Miranda Rights at approximately 1610 hours. Jeremy stated that he understood his rights and continued to talk. Jeremy stated there were items he thought were odd and suspicious that could be used for cooking on a wooden shelf down in the basement. I asked Jeremy if there was going to be any drug contraband inside the residence. Jeremy stated he has been destroying the evidence such as drugs and drug paraphernalia by burning it in the burn barrel behind the house to get rid of it. Jeremy stated that he was cleaning the house out. I advised Jeremy that Dep. Maslanka would be here shortly to transport him to jail. Dep. Maslanka later arrived and transported him to Jail. Jeremy was released to jail staff with no incident. Jeremy was arrested for his warrant out of Mclean County. Dep. Schwerman stood outside with Glenda while the house was being searched. I began to search the residence and located the

following items. I collected pictures of where I found the following items.

\*Clear plastic baggie with white residue in it, located on the living room floor in front of the recliner.

\*Clear plastic baggie with white residue in it, located on the kitchen table next to torches and Glenda's belongings.

\*Clear plastic container with white residue in it. Located on the Kitchen table next to Glenda's belongings.

\*Green / Black Scale with white substance on the scale. Located in the kitchen next to table on a wooden desk.

\*Gray Scale located next to the Green / black scale in the kitchen on the wooden desk.

\*White glass bowl with loose crystal white / brown substance on it that later filed tested positive for methamphetamine and weighed 0.5 grams. Located in the top drawer of a filing cabinet next to bedroom.

\*Clear plastic baggie with crystal white substance inside of it on the white bowl listed above, the crystal white substance field tested positive for methamphetamine and weighed 4 grams inside the baggie. Located in top drawer of filing cabinet next to bedroom. \*Two glass pipes on the white bowl, both had white substance inside of them. Located in the top drawer of filing cabinet next to bedroom.

\*Clear plastic baggie with crystal white substance in it that field tested positive for methamphetamine and weighed 0.5 grams. Located in basement where Jeremy was hiding behind the chair, table, and stairs.

\*Clear plastic baggie with crystal white substance in it located in front of the chair in the basement. The amount in the baggies was not enough to weigh.

\*Black handheld Taser that was located in the bedroom with Glenda's belongings.

While I was searching the house, Lt. Block, Cpl. Park, and Investigator Mayes arrived on scene. They assisted with searching the residence. We did not locate any other drug contraband or weapons inside the residence. Cpl. Park took photographs of the residence while on scene.

It must be noted while in the basement conducting our search, Inspector Mayes and I located several Items that appeared to be suspicious in nature. We located a pump with rubber tubing coming out of the top of it. Towards the bottom of the rubber hose, was a shut off valve. We also located long matches next to a plastic coffee container that had unknown substance inside of it with one long match already burnt also located inside of the container. We located a black container that had liquid inside of it. There were multiple water tubes/hoses in the basement that did not go to anything. Near the chair 0were Jeremy was hiding we located multiple batteries and gloves. We did not observe anything that indicated an active lab.

Inspector Mayes and I spoke with Glenda outside of the residence. Glenda was not under Miranda at this point. At this point, I had not told Glenda what was located in the house or where it was located in the house. Glenda made an unsolicited comment stating, she did not know about the methamphetamine or the glass pipes that were located in the cabinet. I advised Glenda I had not stated what was found or where it was found. I asked Glenda how she knew that was there. Glenda attempted to blame Doug, stating he planted it in the house to get her in trouble. I advised Glenda that Doug has been gone for a couple weeks. I advised Glenda I located two baggies and a plastic container with methamphetamine residue in them. Glenda stated they were not hers and she only goes to the recliner and the kitchen. I advised Glenda, I located multiple items in the kitchen/Living room area. Glenda stated she is blind and cannot see anything and that is why she would not have seen the meth. I advised Glenda she was under arrest and placed Glenda in handcuffs, double locked and checked for fit. Glenda was arrested at 1630 hours. I advised Glenda she was being arrested for possession of methamphetamine and drug paraphernalia.

I transported Glenda to Logan County Jail. Glenda was released to Jail staff with no incident. Glenda was arrested for possession of

methamphetamine under 5 grams, Possession of drug paraphernalia.

Jeremy Eller was arrested for his Mclean warrant and possession of methamphetamine under 5 grams to his charges. Doug was arrested for Violation of order of protection.

The photographs that Cpl. Park collected were uploaded to a DVD to be logged into evidence. I uploaded pictures of evidence to the same DVD as Cpl. Park's. All evidence was secured in evidence bags and secured in my squad car. All evidence was logged and secured in temporary evidence locker #4. I uploaded Dep. Maslanka, Dep. Schwerman, and I in car camera audio video to DVD's to be logged into evidence. I cloud shared the in car camera audio / video footages to the SA Office. I also attached the OOP to this report.

## **Dep. Schwerman Supplemental**

On 07/30/22 at approximately 1227 hours, Deputy Grayson and I were dispatched to Atlanta in reference to an Order of Protection Violation. Dispatch advised Doug Graber was at the residence in a maroon truck. Prior to law enforcement arrival, the caller advised Doug had left the residence. I attempted to locate a maroon truck traveling in the area prior to going to the callers address, I did not locate a vehicle matching the description.

At approximately 1252 hours, I arrived at the address and met with Glenda R. Grass. Glenda stated approximately around 1200 P.M. she was outside working on her vehicle when she noticed a vehicle parked on the road just down from the driveway. Glenda waved at the truck, in an attempt to notify the occupants of the vehicle that she sees them. Glenda did not recognize the vehicle. The truck proceeded to pull into the drive way. Glenda stated the driver complemented her dog as Glenda was walking up to the truck to see who was in the vehicle. Glenda advised as she walked up to the vehicle she noticed Douglas R. Graber (Doug) in the front passenger seat. Glenda has an active Order of Protection (OP) against Doug (2022OP140). Glenda was a protected person on the order of protection, along with the detail address. Glenda told Doug to the leave the property, because he was not allowed to be there. Glenda stated Doug got out of the vehicle and went into the shed. Glenda advised she had broken into the shed on a previous day, to obtain some of her property, because only Doug had a key to the shed. Doug became angry about the shed being broken into and he proceeded to throw stuff in the shed. Glenda stated she then went into the house. Glenda stated Jeremy R. Eller was also at the residence with her during Doug's arrival. Glenda advised Doug was talking to Jeremy prior to Doug leaving the residence. I asked Glenda if I could speak with Jeremy because of him being a potential witness. Glenda stated Jeremy had been picked up by "a female from Bloomington". I asked Glenda for a phone number for Jeremy. Glenda stated she did not really know Jeremy and did not have a phone number for him. I found this to be an odd statement because Glenda stated Jeremy had been staying at the property for several days. Glenda did not know who the driver of the vehicle was but, described the driver of the vehicle as being a heavy set male with shorter hair. The vehicle was described as a maroon truck similar to her truck. Glenda's vehicle is a maroon 2008 Chevrolet Colorado. Prior to leaving the residence, Glenda wanted to report to me Doug had a meth lab in the shed on the property.

Deputy Grayson located Doug at the Shell Gas Station in Atlanta, I relocated to the gas station. It should be noted while in route to the gas station, I ran Jeremy R. Eller through my in car computer and saw that he had an arrest warrant out of McLean County, IL. At the gas station, I met with Deputy Grayson, who advised Doug was in a gray Ford truck in the drive through of the Dairy Queen restaurant, which was attached to the gas station. There was a heavier set individual in the driver seat, who was later identified as William E. Feezor and Doug was in the front passenger seat. I recognized Doug from previous interactions with him. After receiving their food from the drive through window, William pulled up to Deputy Grayson and my squad car to talk with us. Deputy Grayson spoke to Doug in his vehicle and I spoke to William while he was seated in his front seat. William stated he lives in Armington, near where Doug has been staying. William had hired Doug to move some lumber off of a trailer and as payment William was going to buy Doug lunch. William stated he drove through the country to Atlanta. William advised he drove by Doug's house. Doug told him that was where he lived. William stated as they were driving by Glenda was outside and waved them up to the house, so he pulled into the driveway. William did not get out of the vehicle, but Doug did get out of the vehicle and went into the shed. William did not believe Doug had taken anything out of the shed. William advised he had overheard Glenda say to Doug that he was not supposed to be there and he needed to leave because she "has a meth lab". William stated he does not do drugs and did not want to be a part of anything illegal so they left. William voluntarily filled out a written statement about the incident. Doug was arrest by Deputy Grayson for Violation of Order of Protection. Deputy Grayson transported Doug to the Logan County Jail. I relocated back to Glenda's residence to follow up further with her.

I made contact with Glenda to see if she would be willing to fill out a voluntary written statement. Glenda agreed to fill out a written statement. After Glenda completed the written statement, I asked if Glenda would give us consent to search the house, garage and shed, because of the statements made about a possible meth lab. Glenda granted consent to a search of the property and filled out a consent to search form. After Glenda signed the consent form, Deputy Grayson asked Glenda if Jeremy was in the basement. Glenda responded he was in the basement and he had just been brought back from when he left earlier. Because of Jeremy's active warrant, Deputy Grayson and myself entered the residence and went to the basement to locate Jeremy. Jeremy was located under the stairs of

the basement. The underside of the stairs was an open concept and you could pass through from side to side. I went to the right side of the stairs while Deputy Grayson spoke with Jeremy. While on the right side of the stairs I had my duty firearm un-holstered and kept it at my side. I never pointed my firearm at Jeremy. Jeremy advised he knew he had the warrant for contempt of court and was going to turn himself in tomorrow. The basement was completely dark when we went down and I observed several knives scattered on the floor of the basement. At approximately 1454 hours, Jeremy was placed into properly fit and double locked handcuffs. Jeremy was secured in the back of Deputy Grayson's squad car until Deputy Maslanka arrived on scene to transport Jeremy to the Logan County Jail. It should be noted, at approximately 1501 hours I read Jeremy his Miranda Rights, which he stated he understood.

Deputy Grayson began the search of the house, while I sat outside with Glenda. It should be noted that my in car audio/video system was activated during this interaction. Glenda and I had general conversation about her health, family and otherwise general conversation. While speaking with Glenda, she asked if she was getting arrested, I stated not right now. Glenda continued to make statements about finding drug paraphilia in the house and who owned what in the house. I explained to Glenda because she is making these statements I was going to read her Miranda Rights. At approximately 1522 hours, I read Glenda her Miranda Rights. Glenda stated she under stood her rights. Glenda denied ownership to anything illegal in the house. Glenda advised because of her health she is not supposed to walk very much and only occupies the living room, kitchen and her bedroom. While speaking with Glenda she stated she has mentioned to law enforcement about drugs being in the house. Glenda said last night she dumped some drugs down the toilet, because she did not want them around her. I explained to Glenda next time she finds drugs that she should contact law enforcement to turn the drugs over. Glenda goes on to explaining that about 4 to 5 years ago she became addicted to smoking crack cocaine. During the conversation, she denied multiple times that anything illegal, located inside the house was hers. Glenda stated that Doug was trying to set her up by planting meth inside the residence. Investigator Mayes, who had arrived on scene earlier, began speaking to Glenda I walked away from the conversation.

At the Logan County Safety Complex, Glenda's written statement was scanned in and submitted with this report.
