Dep. Grasyon Narrative

On 07/31/22 at approximately 1456 hours, I was patrolling north in the 2000 block of Rt. 121, I observed a vehicle traveling 64 MPH in a 55 MPH zone. I turned around southbound on Rt. 121 and activated my emergency lights, and initiated a traffic stop. We came to a stop at Rt. 121/2000 Ave. Vehicle was a Chevrolet with Illinois registration of [REDACTED]

I approached the passenger side of the vehicle. The male driver, later identified as CJ Sweck, rolled the passenger window down. I could smell a strong odor of cannabis coming from the vehicle. I asked CJ for his license and proof of insurance. CJ stated he did not have his license with him but would give me his information. CJ provided his name and date of birth. The female passenger, who later identified as Heather Ashby, showed me valid proof of insurance for the vehicle. Heather stated the vehicle was hers. I asked Heather for her information, Heather handed me her license. I took her license back to my squad car and ran CJ and her information.

CJ came back clear and valid. Heather came back clear and valid. I walked up to the driver side of the vehicle and asked CJ to come to my squad car to speak with me. I began to fill out a written warning for speed to CJ. I asked CJ if there was any cannabis in the vehicle. I advised him I could smell an odor of cannabis coming from the vehicle while I was speaking with him at the vehicle. CJ stated that there was no cannabis in the vehicle and that one of his coworkers had been in the vehicle and the smell was from that. CJ stated that he hangs out with a lot of people who smoke weed and the smell was stuck to him and the vehicle. I advised CJ I was going to search the vehicle.

CJ, while in my passenger seat, stated “damn it man” then threw his hands up and opened the door and stated “I will just give it to you”. I advised CJ to close the door and to stay in the vehicle. I advised CJ that if there was something in the vehicle that he needed to tell me, because I was going to find it anyways. CJ stated that he had cannabis in the vehicle in the trunk of the car. CJ stated that it was in a book bag. I advised CJ I would allow him to go up and get his daughter and wife out of the car and stand with them at the hood of their vehicle. I issued CJ his copy of his written warning before he exited my squad car.

I walked up with CJ to the car and waited for him to pull his wife and daughter out of the car. CJ explained to Heather that he has cannabis in the trunk of the vehicle and that was why I was going to search the vehicle. I searched the vehicle and located a black leather book bag that contained 22 clear plastic baggies that contained cannabis inside of them, a black scale, plastic measuring cup, and 100 gram weight for the scale. There was a small amount of cash, \$50 that was given back to CJ at a later time. I secured the black bag in my squad car. I asked CJ to come speak with me at my squad car.

I asked CJ if he sells the cannabis, he stated that he does not really sell the cannabis that he more so gives the cannabis away. CJ stated that he uses an old gangster method that he gives cannabis to people for them to watch over him and his stuff. I asked CJ where the cannabis came from and he stated Ricco but did not know his real name. I asked where Ricco got the cannabis from, CJ stated Chicago. CJ stated that Ricco gave him the bag and that he was not sure how much exactly was in the bag but just knew it was 100 or more grams. I advised CJ that I was going to release him with a written warning for the speed and that I would type a report up and send it to the states attorney’s Office for pending charges.

CJ, Heather and his daughter left together with no incident. I secured the evidence in to plastic evidence bags and logged them in to evidence. I secured the evidence in to temporary evidence locker #4. I weighed the 22 baggies for a total amount of 114 grams. I took pictures and uploaded them to a CD that was logged into evidence. I uploaded my in car camera audio / video to a DVD that was logged in to evidence. I cloud shared my in car camera audio / video footage to the Logan County State’s Attorney’s Office.
