Dep. Grayson Narrative

On 08/04/22 at approximately 0722 hours, while patrolling south on Main St approaching 5th St in Middletown IL, I observed a male driving a maroon truck with no front registration plate. I pulled behind the vehicle on to 1250th St headed eastbound. I observed the truck to have a rear Illinois registration [REDACTED]. I activated my emergency lights at 1250th St / 100 Ave to initiate a traffic stop. The vehicle continued to drive southbound on 100 Ave. we came to a stop in the 1200 block of 100 Ave. The male jumped out of the driver side of the truck and began walking to the back of the residence. I gave verbal commands for the male to stop and come talk to me. The male stated he did not have to due to him being on private property.

I advised the male I needed his license. The male, later identified as Ralph Hurt, stated he did not have his license and left his wallet at home. I advised Ralph to get into my passenger seat of my squad car to run his information. Ralph stated that he was not going to get into my squad car. I advised Ralph that I knew him to be suspended due to running his information prior to the traffic stop. I advised Ralph that he was going to be detained for now. Ralph stated "your being a little bitch" for pulling him over. I placed Ralph in handcuffs double locked and checked for fit. I placed Ralph in the back seat of my squad car. Ralph stated "this faggot is going to take me to jail" and continued to call me a "little bitch".

Ralph stated he needed his phone from his truck. I went to the truck and opened the driver door and could smell and odor of cannabis coming from the vehicle. I grabbed Ralph's phone and placed it in the passenger seat of my squad car. I searched Ralph's truck and located a plastic baggie with cannabis inside of it. I located a purple metal container with cannabis inside of it. I completed searching the vehicle and did not locate any other drug contraband. I secured the cannabis in a plastic evidence baggie and secured them in my squad car. I asked Ralph if he had insurance for the vehicle, Ralph stated he did not and that was why he was suspended.

I requested first available Tow through Logan Dispatch. Logan Dispatch advised RBC Towing service was en route to my location. I issued Ralph a citation 228123 for driving while suspended. Citation 228124 operating uninsured vehicle. Citation 228125 for improper display of registration. Civil Citation 00933 for possession of cannabis in motor vehicle. Ralph was given his copies of citations. RBC Towing arrived shortly after and took possession of the truck. I advised Ralph that he was free to leave. Ralph exited my squad car.

I uploaded my in car camera audio / video to a DVD to be logged into evidence. I cloud shared my in car camera audio / video to the Logan County States Attorney's Office.
