## **Dep. Grayson Narrative**

**On 08/12/22 at approximately 1436 hours, I was sitting stationary in my marked squad car in the 300 block of North Drewley St, Atlanta IL. I observed a vehicle traveling eastbound on E Sycamore St, I pulled behind the vehicle off of N Drewley St onto E Sycamore St. The vehicle had temporary Illinois registration [REDACTED], registered to Nicole Rutherford. I observed the vehicle fail to signal turning left off of E Sycamore St, onto N Howard St. I activated my emergency lights and initiated a traffic stop. We came to a stop at [REDACTED]**

**A female later identified as Nicole Rutherford exited the driver side of the vehicle and turned around to face my squad car. I advised Nicole that she was not free to leave. I advised Nicole that she failed to signal turning of E Sycamore St on to N Howard St. I advised Nicole to come back to my squad car to run her information. I knew Nicole to be suspended from running her information previously. I ran Nicole's information, Nicole came back suspended and clear. I asked Nicole if she had insurance for the vehicle. Nicole stated she did at one point. I asked Nicole to show me proof of valid insurance. Nicole could not provide proof of valid insurance.**

**I called first available towing service through Logan County Dispatch. Logan County Dispatch advised AA towing service was en route to my location. I completed my tow inventory of the vehicle. I issued Nicole a written warning #28785 for no turn signal. I issued a citation #228256 for driving while license suspended. I issued a second citation #228258 for no valid insurance. I issued Nicole her copies of citations and advised her she was free to leave.**

**AA Towing Service arrived on scene and took position of the vehicle. I issued AA Towing service their copy of the tow sheet. I uploaded the tow sheet to this report along with the citations that were issued. I uploaded my in car camera audio / video to a DVD to be logged into evidence. I cloud shared my in car camera audio / video to the Logan County States Attorney's Office.**
