Dep. Grayson Narrative

On 8/14/22 at approximately 1124 hours, I was sitting stationary on Highway 136 in the 600 block. I observed a van to pass me. I pulled behind the van with Illinois registration **Figure 1** I ran the van's registration, it came back expired 01/22 registered to John Ratburn. I activated my emergency lights and initiated a traffic stop, we came to a stop U.S. Highway 136 at 600th Ave. I approached the driver side of the van and stated to the male driver, later identified as Jacob Stewart, that his registration was expired. I asked Jacob for his license and proof of insurance. Jacob provided me valid insurance and his license. I took Jacob's license back to my squad car to run his information. Jacob came back valid and wanted out of Mason County for failure to appear. I ran Jacob's information through Logan Dispatch to confirm the warrant. Logan Dispatch confirmed Jacob's warrant, as an active warrant for failure to appear for a traffic offense driving while license suspended.

I approached the vehicle and advised Jacob he had a warrant out of Mason County for failure to appear for driving while license suspended. Jacob stated that he had already taken care of the warrant. I advised Jacob the warrant was still valid. I asked Jacob to exit the vehicle and to come to my squad car while Logan Dispatch waits for the confirmation from Mason County. Logan Dispatch advised the warrant was still valid and stated if Jacob could post bond that he could do so at the Logan County Jail. Logan Dispatch advised if he could not post bond to give Jacob a notice to appear.

Jacob advised he could post bond. I secured Jacob in handcuffs and placed him in my squad car. An off duty Conservation Officer arrived on scene. I asked Jacob for consent to search his vehicle. Jacob gave consent to search. The off duty Conservation Officer stood with Jacob at my squad car while I searched the vehicle. I did not locate any weapons or drug contraband in the vehicle. I secured Jacob's vehicle, and transported Jacob to the Logan County Jail. Jacob was booked and released after he posted bond. I transported Jacob to his vehicle and advised him he was free to leave.

Jacob was arrested on his warrant # W21Q2258 for failure to appear for DWLS. Jacob bond amount was \$5,000 at 10%. Jacob bonded out at \$500.
