On the same CD-Rs, I uploaded the Logan Dispatch phone recording of the phone call that I received from Logan Dispatch supervisor Becky Langley.

I believed Victoria to be under the influence of alcohol due to her slurred speech and swaying while she was standing. I could smell a strong odor of an alcoholic beverage coming from Victoria's person. Victoria stated she was upset her 24 year old daughter, Allyson Baumann, was outside speaking with her father on the phone. Victoria stated "Allyson was a back stabber and needed to go live with her father".

Next, I spoke with Allyson. I asked Allyson if she wanted to stay here and was okay with staying with her mother Victoria for the night. Allyson stated as long as Victoria left her alone there would not be any other issues. I advised Allyson and Victoria they both needed to go inside and sleep it off. It appeared both of them were under the influence of alcohol.

On 08/24/22 at approximately 2327 hours, Logan Dispatch advised there was an active domestic disturbance going on at Logan Dispatch advised they were on the phone with the daughter, and the mother seemed to be the aggressor. Logan Dispatch stated they could hear the mother yelling at the daughter. Logan Dispatch advised that the verbal argument had become physical. I advised Logan Dispatch I was en route.

I arrived on scene and could not hear active yelling. I knocked on the front door. A female came to the front door who I knew to be Victoria Baumann. I spoke with Victoria outside on the front porch and asked her what was going on. Victoria stated that Allyson was screaming for no reason and was acting up. Victoria stated she did not know what to do so she took Allyson's phone and called Logan Dispatch. I advised Victoria that Allyson had been on the phone with Logan Dispatch through the whole incident. Victoria replied with "ok". I advised Victoria to stay out on the porch while I spoke with Allyson. I did not observe any markings or signs of battery on Victoria. I asked Victoria if she had been hit at all. Victoria stated she was never touched by Allyson.

I went into the residence to speak with Allyson. I walked into Allyson's room and observed Allyson sitting on her bed, crying. I asked Allyson what had happened. Allyson stated that her mom, Victoria, came into her room and started to yell at her for being on the phone with her father, Jim Baumann. Allyson stated that Victoria took her phone away from her and that was when it had become physical between the two. I asked Allyson how it became physical. Allyson stated Victoria swung her right hand with an open hand and back-handed her in the chest. I observed there to be a red mark that appeared to be from the back of a hand on Allyson's chest. I collected pictures for evidence that was uploaded to a CD and logged into evidence. I asked Allyson if she would provide a written statement. Allyson stated she would.

I went outside to my squad car to grab written statement forms. I asked Victoria if she would be willing to fill out a written statement. Victoria stated she did not want to. I advised her to stay outside until another deputy arrives. I walked into the residence to give Allyson a written statement, and observed Victoria to walk inside. Victoria was standing by the room door and appeared to be listening to what Allyson was saying. I advised Victoria to go back outside and wait for another Deputy to arrive. Dep. Lasanska arrived on scene shortly after. Allyson completed her written statement. I issued Allyson her copy of the Illinois Domestic Violence Information Act paperwork and asked if she had any questions. Allyson asked if a Deputy could stand by while she packed her belongings and loaded them up when her father and boyfriend arrived. I asked how far away her father was. Allyson's father was on the phone and stated that he was approximately 2 hours away in Naperville IL. I advised her father, Jim Baumann, that when he gets to town that he could call and request a Deputy, and we would come stand by while Allyson collected her belongings.

I went outside to speak with Victoria. I asked Victoria how she was able to get the phone without a physical altercation. Victoria stated Allyson just handed the phone over. I asked Victoria if Allyson hit her or pushed her at any time. Victoria stated she did not. I advised Victoria that Allyson had a red mark on her chest as if she was hit. Victoria stated she never hit Allyson. I advised Victoria that Logan Dispatch heard the altercation and her being the aggressor of the situation. I advised Victoria that due to Allyson having a mark on her and stating she was hit by Victoria that I would be arresting her for Domestic Battery.

I placed Victoria in handcuffs, double locked and checked for fit. I placed Victoria in the back seat of my squad car. I read Victoria her Miranda Rights. I transported Victoria to Logan County Jail. I released Victoria to Logan County Jail staff with no other incident. Victoria was arrested for Domestic Battery.

On 08/25/22 at approximately 1800 hours, I spoke with Jim Baumann on the phone in reference with the domestic last night. Jim stated he was on the phone with Allyson and could hear his ex-wife, Victoria, yelling at Allyson and at one point heard Victoria take Allyson's phone. Jim stated he thought he heard Victoria hit Allyson. I asked Jim why he thought that. Jim stated he heard what he sounded like Allyson hitting the ground then crying and screaming.

On 08/25/22 at approximately 1900hrs, I arrived to 601 N Grove St, to stand by for Allyson to get the rest of her property. I arrived Allyson stated that she got what she needed and did not need a stand by. I asked Allyson if she had any bruising or marks from where she was hit yesterday by Victoria. Allyson stated she did not have any markings. Allyson was wearing a shirt that did not allow her to pull her shirt down to show me her chest area, where she was hit the night prior. I advised Allyson if she needed anything else to contact the Logan County Sheriff's Office.
