Dep. Grayson Narrative

On 08/29/22 at approximately 1909 hours, I was sitting stationary in my marked patrol vehicle at E. State Rt. 121 and 300 St. in Latham IL. While sitting stationary I observed a vehicle traveling southbound with one headlight. I pulled behind the vehicle with Mississippi registration [REDACTED] that was registered to Genesis Floyd, southbound on Rt. 121. I activated my emergency lights, and initiated a traffic stop. We came to a stop at Rt. 121 and 2400 Ave.

I approached the passenger side of the vehicle. I could smell an odor of cannabis coming from inside of the vehicle. I asked the female driver later identified as Tamara Franklin for her license and proof of insurance. I asked the female passenger later identified as Genesis Floyd for her license. They both provided me their license and Tamara provided valid insurance. I advised both of the females due to the odor of cannabis coming from the vehicle, I was going to have them exit the vehicle and come back to my squad car.

I asked Tamara to sit in my front passenger seat of my squad car, and advised Genesis she could sit in the back passenger seat of my squad car to stay out of the rain. I ran both Tamara and Genesis information. Tamara came back suspended and clear of warrants. Genesis came back clear and valid. I advised Tamara that she was suspended and would be issued a citation. I advised Genesis that she would have to drive her vehicle home.

I searched the vehicle and only located small roaches approximately ½ inch from tobacco wraps filled with cannabis inside of them (known as a blunt) in the ash tray. I did not locate any other drug contraband or weapons in the vehicle. I advised Tamara and Genesis that they needed to clean the ash tray out so the vehicle did not have an odor of cannabis inside of it.

I issued Tamara a citation #228269 for driving with a suspended license. I issued Tamara a written warning #28794 for driving with one headlight. I issued Tamara her copies of her citation and written warning and advised Tamara and Genesis they were free to leave. Genesis drove her vehicle form the scene.

I uploaded a DVD with my in car camera audio / video to be logged into evidence. I cloud shared my in car camera audio / video to the Logan County States Attorney's Office.
