Dep. Grayson Narrative

On 09/02/22 at approximately 2250 hours, I observed a dark colored van roll through a stop sign at South Madison St. and 3rd St. in Middletown IL. I was able to catch up to the van with Illinois registration [REDACTED] registered to William Withers, at 5th St and 100 Ave. I asked Logan Dispatch to run William Withers information. Logan Dispatch advised William was valid, and had an active warrant out of Logan County for delivery of methamphetamine. Warrant number 21CF255. I activated my emergency lights and initiated a traffic stop. We came to a stop at 100 Ave. and 1000 St.

I shined my spot light on the vehicle and could observe William Withers in the driver seat and was the only occupant in the vehicle. I know William from previous police contacts. I approached the driver side of the vehicle. I advised William that he had an active warrant out of Logan County for failure to appear for delivery of methamphetamine. I asked William to exit the vehicle. William complied and exited the vehicle. I placed William in handcuffs, double locked and checked for fit. I searched William for contraband with negative results and placed him in the back seat of my squad car.

I conducted a search of the vehicle and did not locate any contraband or weapons. I requested first available towing service through Logan Dispatch. Logan Dispatch advised RBC Towing Service was en route to my location. Cpl. Becker arrived on scene and stated he would stay with the vehicle until RBC Towing arrived. William was complaining about the handcuffs and his shoulders. I added an extra pair of cuffs to William to extend them out further. I secured the handcuffs, double locked and checked for fit.

I transported William to Dewitt County, due to Logan County Jail being full. William was released to Dewitt County Jail staff with no incident. William was arrested for his warrant out of Logan County.

I uploaded my in car camera audio / video to a DVD to be logged into evidence. I also shared my in car camera audio / video to the Logan County States Attorney's Office.
