On 09/03/22 at approximately 0213 hours, I was patrolling northbound on Vine St in Mt. Pulaski IL, approaching a stop sign with North Topper Dr. I observed a black Jeep turning onto North Topper Dr. off of Vine St. in the southbound lane and drive into the northbound lane. I pulled behind the Jeep with Illinois registration [REDACTED] registered to Peggy Osaman. I activated my emergency lights and initiated a traffic stop. We came to a stop at Rt. 121 and lamplighter Circle.

I approached the passenger side of the vehicle and advised the female driver that I pulled her over for improper lane usage. I asked the female who later identified as Danielle Morris, for her license and proof of insurance. Danielle advised this was not her vehicle and did not know where the insurance was at. Danielle handed me her license and stated that it was expired. I took Danielle's license back to my squad car to run her information.

I ran Danielle's information and observed that she was suspended. I ran Danielle's information through Logan Dispatch to confirm that she was suspended. Logan Dispatch confirmed Danielle was suspended. I approached the vehicle and advised Danielle that she was suspended, and did not have a valid license due to her license being expired since 2009. I asked Danielle to exit the vehicle and come back to my squad car. I asked Danielle if there was any drug contraband or weapons in the vehicle. Danielle stated there was not and gave verbal consent to search the vehicle.

I searched the vehicle and did not locate any weapons or drug contraband. I went back to my squad car and asked Danielle if she was able to get proof of insurance. Danielle stated she could not provide valid insurance. I requested first available towing service through Logan Dispatch. Logan Dispatch advised Ron's Towing Service was en route to my location.

I issued Danielle a written warning for improper lane usage written warning #29952. I issued Danielle a citation #228270 for driving while license suspended. I issued Danielle her copies and advised her she was free to leave. Danielle had a friend come pick her up to take her home. Ron's Towing Service arrived on scene shortly after. Ron's Towing Service took possession of the vehicle.

I uploaded my in car camera audio / video to a DVD to be logged into evidence. I cloud shared my in car camera audio / video to the Logan County States Attorney's Office.
