Dep. Grayson Narrative

On 09/03/22 at approximately 2011 hours, I drove through Casey parking lot, and observed a Tan Buick with IL, registration [REDACTED] that came back expired. I ran the registration in my squad car and observed the registration to be expired 10/21. I left the Casey parking lot and parked stationary in my marked patrol vehicle, at US Highway 136 and First St. in San Jose IL. I observed the same tan Buick with Illinois registration [REDACTED] that registered to Cheyenne Lee traveling west on Highway 136. I pulled behind the vehicle, activated my emergency lights, and initiated a traffic stop. We came to a stop at US Highway 136 and Third St.

I approached the passenger side of the vehicle and asked the female driver for her license and proof of insurance. The female identified as Cheyenne Lee. Cheyenne provided valid proof of insurance and stated she did not have her license with her. I asked Cheyenne to come back to my squad car to run her information in my squad car. I ran Cheyenne's information. Cheyenne came back suspended and clear of warrants. I advised Cheyenne she was suspended, and verified her by her Secretary of State Identification photograph. I asked Cheyenne if she could have anyone come drive her vehicle home. Cheyenne stated she could have her friend come pick her and the vehicle up.

I issued Cheyenne a written warning #29955 for expired registration and a citation #228272 for Driving while suspended. I issued Cheyenne her copies of written warning and citation. I asked for consent to search the vehicle, Cheyenne gave verbal consent to search the vehicle. I searched the vehicle and did not locate any weapons or drug contraband in the vehicle. I waited for Cheyenne's friend to arrive to take possession of the vehicle. Cheyenne's friend arrived shortly after. I advised Cheyenne she was free to leave.

I uploaded my in car camera audio / video to a DVD to be logged into evidence. I cloud shared my in car camera audio / video to Logan County States Attorney's Office.
