Dep. Grayson Narrative

On 09/07/22 at approximately 2338 hours, I was sitting stationary in my marked patrol vehicle at Woodlawn Rd. and Madison St. in Lincoln IL. While sitting Stationary in my squad car talking to Officer Antoine, we observed a male walk up to the passenger window of a red SUV, and do a hand to hand transaction. The transaction was approximately 15 seconds long before both parties separated. I observed a red SUV with a broken taillight pull out of Discount Tobacco store, on to North Monroe St. I pulled on to North Madison St. I pulled on to Woodlawn St. I turned on to North Monroe St, to get behind the vehicle and observed the vehicle to be driving southbound on North Monroe St. I sped up to catch up to the vehicle and observed the vehicle to turn left on to 13th St without using a turn signal. I observed the vehicle to shut its lights off and continue to drive. I activated my emergency lights and initiated a traffic stop. The vehicle turned off of North Monroe St. on to 13th St and failed to slow down and drove through a stop sign at 13th and Adams St. The vehicle took a right turn on to Adams St. and turned left onto 12th St. we came to a stop at 12th and State St.

I observed the driver door to open and shut quickly. Officer Antoine was on scene with me, Officer Antoine approached the passenger side of the vehicle, as I approached the driver side of the vehicle. I observed there to be a female sitting in the passenger seat of the vehicle breathing heavy as I could see her chest rising and falling at a fast pace. I advised Officer Antoine the driver was now in the passenger seat. I opened the driver door, and spoke with the female who later identified as Faith Stagnolia. Faith began to cry and stating she did not have a license.

I asked Faith to exit the vehicle, and to come speak with me at my squad car. While speaking with Faith at her vehicle I could EXPUNGED coming from the vehicle. I observed there to be multiple EXPUNGED in the vehicle. Faith exited the vehicle and came back to my squad car. I asked Faith if she never had a license before or if it was suspended or revoked. Faith stated her license was suspended. I advised Faith that driving like she did could make her lose her license for even longer, or could cause her to be arrested.

I ran Faith's information in my squad car. Faith was suspended and clear of warrants. I ran Faiths vehicle registration - Illinois registration [REDACTED] it was registered to Faith. I advised Faith I was going to search the vehicle due to EXPUNGED coming from the vehicle. I searched the vehicle and located EXPUNGED inside of it, in the cup holder in between the driver and passenger seat. I collected the EXPUNGED to be logged into evidence. I secured the EXPUNGED in my squad car.

I advised Faith I was going to issue her a written warning for disobeying a stop sign written warning #29961. I issued Faith a citation #228726 for driving while suspended. I issued Faith a EXPUNGED. I asked Faith to provide valid insurance for the vehicle. Faith provided insurance for the vehicle. I asked Faith if she could have someone come pick her and her car up. Faith called her mother to come get her and the car. Faith's mother arrived on scene shortly after and took possession of the vehicle.

I uploaded my in car camera audio / video to a DVD to be logged into evidence. I cloud shared my in car camera audio / video to the Logan County States Attorney's Office.
