Dep. Grayson Narrative

On 09/08/22 at approximately 0053 hours, I was traveling East on 5th St. in Lincoln IL when I observed a red SUV turn its lights off while driving on 5th St. I observed the red SUV turn left onto State St., and I sped up to catch up to the vehicle. I turned on to State St. and observed the vehicle already to be to be turning onto 7th St. I continued to attempt to catch up to the vehicle. I turned onto 7th St. and observed the vehicle to have taken an alley road towards 8th St, this alley road way comes to a dead end. I observed the vehicle back up on 8th St. and at an estimated speed of 35-45 MPH drive towards State St, failing to stop at any stop signs.

I continued to follow the vehicle to State St. The vehicle continued to speed and ran a stop sign on State at 6th St. I activated my emergency lights and sirens in attempt to get the vehicle to stop. The vehicle drove from 6th St to Maple St. The vehicle drove on Maple St. to 5th St. From 5th St. At 5th St. and Maple St. the vehicle almost struck Officer Antoine's marked squad car, due to the vehicle turning its lights off while driving. Officer Antoine then turned around and pursued the vehicle.

The vehicle continued to drive from Maple St. to 4th St. The vehicle turned right on to 4th St. and turned its lights off again. The vehicle turned its lights back on and came to a stop at 4th St. and Pine St. The red SUV was a Ford with Illinois registration that was registered to Christopher Werth. Officer Antoine approached the vehicle with me.

I asked the male who was later identified as Marshall Bradley to exit the vehicle. I placed Marshall in handcuffs, double locked and checked for fit. I advised Marshall at this time he was being detained for reckless driving. I placed Marshall in the back seat of my squad car. I asked Marshall for his full name and date of birth. I approached the passenger side of the vehicle to speak with the female passenger identified later as Destiny Lyons. Destiny provided me with her license. I asked destiny why Marshall was driving like that, Destiny stated she did not know. I asked Destiny where they were headed to. Destiny stated they were just out cruising and Marshall was going to take her home.

I ran Marshall's and Destiny information through Logan Dispatch. Marshall came back clear and valid. Destiny came back clear and valid. I asked Marshal if there was any weapons or drug contraband in the vehicle. Marshal stated there was not and gave verbal consent to search the vehicle. I asked Destiny to exit the vehicle. I searched the vehicle and did not locate any weapons or drug contraband.

I advised Marshall that he was speeding, ran multiple stop signs (approximately 3-4), and was driving without his lights on. I advised Marshall that his conduct was dangerous and he could have easily killed someone walking or riding a bike. I advised Marshall without his lights on and speeding and not stopping he would not of been able to see anyone in the road way.

Officer Antoine advised Marshall that he almost struck his squad car at 5th St. and Maple due to him speeding and not having his lights on. I advised Marshall that he could be going to jail due his reckless driving.

Marshall apologized and stated that he thought the stop signs were yield signs. Marshall stated he was speeding because he thought my marked patrol vehicle was someone that did not like him and was looking for him. I advised Marshall my squad car was full marked with Logan County Sheriff on the front and back and on both sides of the vehicle.

I released Marshal from handcuffs and had him sit in the front passenger seat of my squad car. Marshall stated he thought the stop signs were yield signs and advised he was sorry for making us have to deal with him. I issued Marshall a citation #228727 for reckless driving. I released Marshall with his copies of citation and advised him he was free to leave.

I uploaded my in car camera audio / video to a DVD to be logged into evidence. I cloud shared my in car camera audio / video to the Logan County States Attorney's Office.
