## Dep. Grayon Narrative

On 09/16/22 at approximately 2142 hours, I went to the residence of [REDACTED] for a follow up for a pending investigation. I knocked on the door and spoke with Kenneth Young, who stated that the only people in the residence was Gage Fletcher, and himself. I asked Kenneth if he lived at the residence. Kenneth stated that he lives at the park and stays here on and off. I asked who lived at the residence, Kenneth stated that Gage and a couple other people live at this address. Kenneth stated that Harry stays at the residence sometimes and Victoria Green, Harry Green's Wife.

I went back to my squad car and sat out front of the residence. I observed a female to arrive on a bicycle, who later identified as Shelby List. I asked Logan Dispatch to send me SOS images of Gage Fletcher and Kenneth Young. I knew from prior conversations with Cpl. Becker that Gate Fletcher had two warrants out for his arrest. I ran Gage's information in my squad car and confirmed Gage's two warrants. I advised Cpl. Becker and Lt. Block that Gage was at the residence. Officer Antoine arrived on scene and approached the residence with me.

I knocked on the door, Kenneth answered the door. I asked Kenneth to step out of the residence. I asked Kenneth where Gage was at in the residence. Kenneth stated that Gage left an hour ago. I advised Kenneth he did not due to me siting on the house and watched who arrived and left. I advised Kenneth that no one left the residence. I asked Kenneth who the female was in the house. Kenneth stated he did not know. I asked the female to come out of the residence. I asked Shelby for her information, and asked her where gage was at. Shelby stated she did not know.

Officer Antoine made contact with the home owner Harry. Harry advised that no one should be in the residence and he kicked everyone out weeks ago. Officer Antoine advised there was a male and female in the residence. Officer Antoine asked Harry for permission to enter the residence to get Gage. Harry gave permission to enter the residence. Officer Antoine and I entered the residence to look for Gage. We cleared the house and walked outside to the back yard. I observed Gage to be crouched down between a shed and garage. I advised Gage to come to me and speak with me.

I advised Gage that he had two warrants for his arrest. I advised Gage he had a warrant out of Mason County #22-057 failure to appear for speeding with no insurance. I advised Gage he had a Logan County warrant #2022CM5 for failure to appear on theft. I placed Gage in handcuffs double locked and checked for fit. I placed Gage in the back seat of my squad car.

I transported Gage to the Logan County Jail. Gage was arrested for his two warrants out of Mason County and Logan County. Gage was released to Jail staff with no incident.
