Dep. Grayson Narrative

On 10/02/22 at approximately 2058 hours, I was patrolling East in the 500 block of Highway 136, I observed a car flashing its head lights on and off while headed westbound. As the vehicle passed me I observed there to be big objects hanging off the mirror. I completed a U-turn headed westbound to get behind the vehicle. I caught up to the vehicle, a black Toyota Camry Illinois registration The vehicle was registered to Nichole Meagher. I activated my emergency lights, and initiated a traffic stop. We came to a stop in 200 block of Highway 136.

I approached the passenger side of the vehicle and advised the male driver later identified as Braden Meagher, the reason I stopped him. Braden stated that he has a short in the wires for his headlights, which causes them to go on and off when switching from normal headlights to high beams. I asked Braden for his license and proof of insurance. While waiting for Braden to hand me both documents, expunged. I asked Braden where he was headed, he stated he was headed to Havana IL, to a friend's house. I asked Braden what he was going to do while he was there, he stated they were going to be on the river. Braden handed me both documents. I took Braden's license back to my squad car to run his information. Braden was clear and valid. I filled out a written warning #29978 for obstructed windshield.

I approached the vehicle and handed Braden his license and copy of written warning. I asked Braden how much expunged was in the vehicle. Braden stated that he did not have any in the vehicle, but there was probably some in the vehicle that was his moms. I asked Braden if there was any alcohol in the vehicle, he stated not that he knew of. I asked Braden if this was his car that he drives all the time. Braden stated it was, and that his mom uses it sometimes as well. I asked Braden for consent to search the vehicle. Braden gave verbal consent for me to search.

I searched the vehicle and located the following items:

Open 12 pack of Busch beer in the driver side back seat under a hoodie.

I completed searching the vehicle and did not locate any other drug contraband or weapons. I collected the alcohol and expunged and secured it in my squad car. I asked Braden how old he was, Braden stated he was 18 years of age. I advised Braden he cannot have expunged in a motor vehicle or alcohol. I advised Braden that I was going to issue him two citations for expunged and alcohol. I issued Braden citation #228739 for possession of alcohol by a minor. Expunged.

I asked Braden for his parent's phone number. Braden provided me his parents phone number, I called and spoke with Braden's parents. I spoke with Braden's father Kent Meagher and mother Nichole Meagher. Braden mother spoke with me. I advised her of what I had found in Braden's vehicle and that I would be issuing him citations. Braden's father advised that he would have Braden come home. I issued Braden his copies of Citations, and advised him he was free to leave.

I uploaded my in car camera audio / video to a DVD to be logged into evidence. I cloud shared my in car camera audio / video to the Logan County States Attorney's Office.
