On 04/13/23 at approximately 1456 hours, I was traveling eastbound on Keokuk Street approaching Logan Street. I observed a blue van with a broken front windshield. I did a U-turn on Keokuk St, to get behind the van. As I was approaching the van westbound on Keokuk Street, I observed the van's driver side tires to cross the center line, as if the driver was looking in his mirrors to see if I was behind him. The van crossed the center line at the intersection of Keokuk Street and Water Street. I ran the van's Illinois registration [REDACTED] which came back to William J. Withers [REDACTED]. The vehicle's registration came back suspended for mandatory insurance. I initiated a traffic stop by activated my emergency lights at College Street and Woodlawn Road. We came to a stop in the Walgreens parking lot off of College St.

I approached the driver side of the vehicle and met with the driver, William Withers, who I knew from previous encounters. I advised William that his vehicle's registration was suspended. I observed William at this time to be breathing at a fast rate, as I could see his chest moving back and forth as if his heart was beating out of his chest. I observed William's carotid artery to be pulsing in his neck. I observed sweat to form on William's forehead and start to roll down his face. I know these signs to be associated with nervousness. I asked William to come back to my squad car with me to run his information.

As William was approaching my squad car, I asked him if he had anything in his pockets. William stated that he had a small amount of expunged in his pocket. I asked William to give me the bag. William pulled out a clear plastic bag with expunged inside of it from his left side cargo pocket. I recovered the baggie from William and placed it on the hood of my squad car. I asked William if he had anything else in his pockets. William stated he did not think so. I advised William that I was going to search him due to him having a bag of expunged on him.

I searched William and located a expunged used to expunged in William's right side cargo pocket. I located William's wallet in his left side cargo pocket. I opened William's wallet and recovered a small plastic baggie with white powder inside. The baggie was located in a small pouch on the left side of the wallet. I placed William's wallet and the plastic baggie on the hood of my squad car. I advised William at this time he was under arrest. I placed William in handcuffs, double locked and checked for fit. I placed William in the front passenger seat of my squad car. I requested another unit to my location. Dep. Schwerman arrived at my location.

I asked William what he believed was in the plastic baggie, he stated it was possibly cocaine. I asked William how much he believed was inside the baggie, he stated it was .5 grams or less.

I approached the vehicle and asked the female passenger Destiny Gibson to step out of the vehicle. I asked Destiny to sit on the hood of the van while I searched the vehicle. I searched the vehicle and did not locate any contraband in the vehicle.

I asked Logan County Dispatch to run the female passenger Destiny P Gibson [REDACTED]. Logan County Dispatch advised Destiny had a warrant out of Logan County for failure to appear. Warrant #20cm166. Dep. Schwerman placed Destiny under arrest. Dep. Schwerman placed Destiny in his squad car. Dep. Schwerman transported Destiny to the Logan County Jail. See Dep. Schwerman supplemental report.

Sgt. Bauer arrived on scene and handed me a paper evidence bag to place the expunged and white substance in. I later transported the evidence to the Logan County Sheriff Office to log the evidence. I later field tested the white substance which came back positive for cocaine. The white substance weighed in the baggie approximately 1 gram.

I requested next available tow through Logan County Dispatch. Logan County Dispatch advised that A&A Towing service was en-route to my location. A&A Towing arrived shortly after and took possession of William's vehicle. I transported William to the Logan County Jail. Sgt. Bauer removed William's plates from his vehicle to send to Sectary of State.

I arrived at the Logan County Jail with William. I completed the booking paperwork for William. I released William to Logan County Jail staff. I issued William a expunged. I issued William traffic citation #229301 for Improper Lane Usage. I issued William a second traffic citation #229302 for Driving with Suspended Registration for Mandatory Insurance. I placed the plastic baggie into a plastic evidence bag and placed it into temporary evidence locker #2. The white substance will be sent to the Illinois State Police Crime Lab for further testing.
