NARRATIVE:

On Sunday, 03/28/2021, at 2058 hours, I was contacted, via my department issued cell phone, by Forensics Supervisor Nancy Fabela and she advised that an officer involved shooting had occurred in the City of Lompoc. She advised to respond to Santa Maria Substation for details.

I arrived at the Santa Maria substation at 2120 hours. CSI Tech II Amezola and I packed up our Forensic van and left Santa Maria substation at 2130 hours heading towards the city of Lompoc.

CSI Tech II Amezola and I were instructed to respond to the Hilton Garden Inn hotel to process the two Lompoc Police officers that were involved in the shooting. We arrived at the Hilton Garden Inn hotel at 2206 hours.

I assisted CSI Tech II Amezola with the processing of the officers involved (refer to her supplemental report #0008 for details).

After processing the two Lompoc Police officers, we responded to the crime scene, arriving at Walnut and H Street at 0107 hours

PROCESSING OF THE SCENE & EVIDENCE COLLECTION (Items 1-8, 10-14, 16-27 tag#09070108)

Upon arrival at the crime scene, located at East Walnut and North H Street, Lompoc, we found Forensic Supervisor Fabela and CSI Tech II Sandoval. Fabela and Sandoval had already begun processing the crime scene. I assisted in collecting items 1-8, 10-14.

Item 9 (biological matter) was photo documented at the scene and not collected.

Item 15 (cell phone) was collected by Forensic Supervisor Fabela and hand delivered to Detective Alegria. See Forensic Supervisor's supplemental report 0021 for details.

Item 16 was collected by Forensic Supervisor Fabela. This item was later handed to me at the end of the night. I placed item 16 in the Santa Maria Forensic Van with the rest of the evidence to be transported to the Lab for processing.

CSI Tech Amezola collected items 17-27. See attached property form for details and times collected.

CSI Tech Amezola and I left the scene at 0229 hours.

All the evidence was secured in the Forensics van, transported back to Santa Maria Lab where it was locked and secured pending processing.

The suspect's clothing (with suspected blood) was placed in the drying cabinet to dry in our secured Forensic Lab.

I uploaded the photos and crime scene video into the Santa Maria Forensics digital imaging storage under case # 21-3520 for future reference.

DOJ Crime Lab for test firing purposes - see property form for details - a post-it note was photographed in its place) and 17-27, tag # 09070108. See attached property form for details.

At 0920 hours I conducted a DNA search (suspected blood) on item 10, tag#09070108 (grey handle of the 11 $\frac{1}{2}$ inch knife). Using a sterile cotton swab containing distilled water, I swabbed the grey handle of the knife. This item was later booked as item 28, tag #09070108.

I then collected a control swab containing distilled water, which was used to collect item 28. This item was later booked as item 29, tag#09070108.

I then conducted a latent search on item 10, tag #09070108 using the process of super glue fuming. When the super glue fuming process was completed, I used bi-chromatic fingerprint powder (using a sterile, single-use, fiberglass brush) on item 10, tag#09070108. I did not observe any friction ridge detail on the item. This item was independently examined and verified by CSI Tech Amezola.

Photo documentation was completed at 1243 hours. All the photographs were uploaded into the Santa Maria Forensic Unit's digital imaging storage under 21-3520 for future reference.

Items 1-8, 10-14, and 17-29 were packaged, sealed and secured using evidence tape.

Items 1-8, 10-14 and 17-29 (tag #09070108) were delivered to the Santa Maria Property and Evidence office on Wednesday, 04/07/2021 at 1610 hours.
