NARRATIVE:

On Sunday 03/28/2021, at approximately 2030 hours, I received a phone call from Sgt. McDonald informing me of an officer involved shooting within the city limits of Lompoc. Sgt. McDonald told me Lompoc Police Department officers were involved in the shooting, and SBSO was tasked with handling the investigation.

As the Forensics' Technicians were photographing Krys Ruiz, they noticed "Reach in my pocket" written on his right arm. Krys was searched and a folded-up note was located inside a "Ziploc" plastic bag. The note was in his left front pants pocket, and it had the following written on it:

3.28.21 My name is Krys Ruiz, I am a transgender male

My mother's name is

My phone code My date of birth is

I was around much longer than I should have been. Its not anybody's fault but my own

I am giving my mom & sister everything because they know what things have most value

I also want to be cremated so I don't bankrupt my family
