██████████ of Plumb Perfect Plumbing located at 119 East Ocean Ave.
 ██████████ works for Wiser Property Management located at 119 E. Walnut Ave.
 ██████████ works for the Lompoc Valley Association of Realtors located at 139 North G.
 The Offices of Dr. G. Pritchett, Chiropractic Health Center, is located at 133 North G.
 The Offices of Jon Johnson Pool & Spa are located at 129 North G.
 ██████████ resides at 125 North G.

B) EVIDENCE :

A CD with video footage from Plumb Perfect Plumbing was booked into evidence under SBSO case 21-03520, Supplement 0003, Property Tag 09-70107.

Time Stamp Plumb Perfect Plumbing :

On 03-29-21, I observed that the surveillance system showed a time of 12:15:40 when my department issued iPhone showed a time of 09:15:40, a time difference of 3 hours.

C) NARRATIVE:

On 03-29-21, I was requested to assist on this investigation. I was requested to search for surveillance footage near the area of the alley off of Walnut between G and H streets.

Summary - no surveillance footage was collected at the area where the suspect was located (alley between G and H streets off of Walnut). I did not observe the suspect on the footage from the system from Plumb Perfect Plumbing.

-I contacted ██████████ of Plumb Perfect Plumbing. Due to network issues, we were unable to retrieve surveillance footage from the business. I reviewed the live feed of the outdoor cameras, and observed that one of the cameras, camera 1, had a view of the alley, which ended just to the north of the building which houses the Lompoc Theatre. I observed that the area where the suspect was located was out of view of this camera. ██████████ stated that he would contact his tech personnel and attempt to retrieve the footage from 03-28-21 from 1800 hours through 2100 hours. ██████████ later provided the footage on a flash drive. I reviewed the footage (motion activated) but did not observe the suspect in the footage. A copy of the footage was booked into evidence as listed above.

-I contacted ██████████ at 119 E. Walnut and was informed that the location does not have surveillance cameras.

-I did not observe cameras at the location of 112 E. Walnut. There was no answer at the location.

-Chiropractic Health Center, located at 133 North G did not have any cameras.

-Jon Johnson Pool & Spa, located at 129 North G did not have any cameras.

-I contacted ██████████, who resides at 125 N G St, and observed that there was a Ring doorbell camera facing towards G Street (opposite side of the residence and pointed away from the alley). ██████████ reviewed that there were no activations of the camera during the timeframe of 1800-2100 hours

-I contacted [REDACTED] of the Lompoc Valley Association of Realtors, located at 139 North G. I observed a Ring doorbell camera, which was on the opposite side of the structure and pointed away from the alley). [REDACTED] reviewed that the only activation of the camera during the timeframe of 1800 - 2100 hours was for a passing by vehicle.
