#### NARRATIVE:

On Monday, 03/29/21, at approximately 0800 hours, Coroner Detective Brice Bruening stopped by the North County Forensics Office and dropped off the rolled inked exemplars of the decedent *(later identified as: Krys Brandon Ruiz, A.K.A: Yvette Krystella Ruiz)* that he obtained.

Supervisor Fabela was provided with possible decedent's information (*CII*#**COND**, *DOB: 12/08/1994*, *SSN*#**COND** to help with confirming his identity. The exemplar 10-print for CII#A34564014 was requested through California's DOJ Automated Archives System (AAS). One exemplar 10-print print-out, belonging to Yvette Krystella Ruiz, was available. The date the prints were taken was 08/13/2014. The social security matched the information provided to us by Detective Esparza.

#### NGI (ULW) INQUIRY FOR DECEDENT'S RIGHT THUMB PRINT:

On Monday, 03/29/21, I conducted an NGI (ULW) inquiry for the decedent's right thumbprint (*TCN*#202103290837081413). The search yielded negative results.

On Monday, 03/29/21, Supervisor Fabela independently evaluated the NGI returns and verified the results.

#### FINGERPRINT COMPARISON OF DECEDENT'S RIGHT THUMB WITH RIGHT THUMB FROM THE AAS EXEMPLAR 10-PRINT PRINT-OUT (CII#A34564014):

I conducted a Photoshop side-by-side comparison of the decedent's right thumb with the right thumb from the AAS exemplar 10-print print-out (*CII#A34564014*).

#### • Yvette Krystella Ruiz (Krys Brandon Ruiz) was individualized as being the decedent.

On Monday, 03/29/21, Supervisor Fabela independently verified the above comparison results. Detective Esparza was notified of the deceased identification.

High resolution scans (1000 dpi) were made of the decedent's right thumb and the right thumb from the AAS
