 - If it's an apartment building include the unit number
- 3. What type of dog was it? Please provide a <u>DETAILED</u> description
 - Size, Color(s), Breed (If known), Distinguishing features/ Markings (<u>Example</u>. Long fluffy tail, curled tail, Coat length, white chest/ front legs, etc.).
 - If there was more than one dog involved- Be **specific** in describing each dog and how they were involved

<u>Example</u>. The large brown/black German Shepherd ran off the property and attacked my pet while the second dog, a medium white Terrier Mix who also ran off the property bit me on my right leg

4. Where did the incident occur?

- <u>Example</u>. Sidewalk, swale area, street (specify the address or nearest intersection), building hallway, elevator, park, etc.

- 5. Before the incident was the dogs(s) on a leash? Did it remain on a leash during/after the incident?
